Cricket Communications, Inc.

PUCO Certificate No. 90-5446

Cricket Communications, Inc. holds a statewide PUCO Certificate No. 90-5446, issued on October 23, 2002 in Case No. 01-2113-CT-ACE. That case is the case in which this notification would ordinarily be filed under O.A.C. § 4901:1-6-24(C), but it has been archived by the Docketing Department, so this notification is being filed in a new case.

In a transaction that was announced on July 12, 2013 and that was consummated on March 13, 2014, following FCC regulatory approval, AT&T Inc. acquired Leap Wireless International, Inc. (“Leap”), including the wireless licenses - - principally AWS, PCS, and associated microwave licenses and international Section 214 authorizations - - held by Leap and its subsidiaries, which include Cricket Communications, Inc. Mariner Acquisition Sub Inc., a newly formed, wholly-owned indirect subsidiary of AT&T, was merged with and into Leap, leaving Leap as the surviving entity. As a result, Leap is now a wholly-owned indirect subsidiary of AT&T Inc. Leap will continue to operate under the Cricket brand name.

In Ohio, the affected properties include the licenses, retail operations, network assets, and the customer base for the following areas:
