**REQUEST FOR CONTINUANCE**

---

On January 28, 2014, the Public Utilities Commission of Ohio issued a Procedural Schedule in this matter in response to a Status Report filed on January 3, 2014 by Complainant KNG Energy, Inc. (“KNG”). With the consent of KNG’s counsel, on February 17, 2014, Ohio Intrastate Energy, LLC (“OIE”) requested a sixty (60) day extension of all deadlines relative to the January 28, 2014 because the managing member of OIE had recently suffered serious unexpected medical issues with an unknown recovery time. That request was granted on March 11, 2014, and the following procedural schedule was issued:

- (a) April 28, 2014 – Deadline for service of written discovery;
- (b) May 28, 2014 – Deadline for the filing of prefiled testimony;

(c) June 17, 2014 – hearing.

By and through this Motion, OIE requests a sixty (60) day extension of all deadlines relative to the March 11, 2014 Procedural Schedule, and that a new hearing date be set. The recovery time of the managing member of OIE is still unknown.
