**THE EAST OHIO GAS COMPANY D/B/A DOMINION EAST OHIO'S  
STATEMENT INFORMING THE COMMISSION WHETHER  
THE ISSUES RAISED IN COMMENTS HAVE BEEN RESOLVED**

In accordance with the Commission's March 7, 2014 Entry, The East Ohio Gas Company d/b/a Dominion East Ohio (DEO) hereby informs the Commission whether the issues raised in the comments have been resolved. Staff filed Comments on March 27, 2014, stating that it did not have any issues with DEO's Application and recommending that the Commission approve DEO's Application as filed, beginning the first billing cycle of May 2014. (Staff Comments at 7.) No other parties filed motions to intervene or comments in this case.

Because no issues have been raised with the Application, there are none to be resolved, and DEO believes that a hearing in this case is unnecessary. *See* Entry ¶ (4)(f) (Mar. 7, 2014) ("*In the event* that all of the issues are not resolved or the parties enter into a hearing a stipulation, a hearing shall commence . . .") (emphasis added). Therefore, DEO respectfully requests that the Commission approve its March 3, 2014 Application, as filed.
