Dear Ms. McNeal:

On March 17, 2014, the Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need subject to a number of conditions.

Condition No. 22 of the Board's Order requires the following:

Prior to the commencement of construction activities that require permits, licenses, or authorizations by federal or state laws and regulations, the Applicant shall obtain and comply with such permits, licenses, or authorizations. The Applicant shall provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant. The Applicant shall provide a schedule of construction activities and acquisition of corresponding permits for each activity at the preconstruction conference.

In compliance with Condition No. 22 of the Order, and as referenced in Section 4906-15-04(D)(1) of the Amended Application filed November 15, 2013, attached for filing is a copy of the City of Vandalia Privilege/Right-of-Way Permit for all roads within the City of Vandalia.

PRIVILEGE/RIGHT-OF-WAY PERMIT**

Permit # 2014-6

The undersigned being the owner (lessee) of the following described premises, to wit:

- 1 - Corporate Center Drive (39.886996N, -84.222890W), 800 feet south of W National Road
- 2 - Peters Pike (39.886184N, -84.227120W), 830 feet south of W National Road
- 3 - Dog Leg Road (39.883851N, -84.236013W), 1,010 feet south of W National Road
- 4 - Dayton International Airport - Access Road (39.884865N, -84.236013W), 1,030 feet south of W National Road

hereby makes application for permit to perform the following work within said public way:

Install a 12" steel natural gas pipeline under the roadway using directional/conventional boring methods.
Construct a temporary access off the roadway to access the pipeline route. The temporary access would be restored to pre-existing conditions once the installation of the pipeline has been completed.

Said owner/lessee for themselves and heirs, successors, administrators and assigns hereby agree that the license or privileges sought, if granted, shall be exercised within 90 days from date of issue and may be revoked at any time hereafter upon the order of said City; that they will obey all laws of the State of Ohio and ordinances of the City of Vandalia, Ohio, pertaining thereto, whether now in force or hereafter enacted in the installation, maintenance and use of such license or privilege and that all acts or things to be done in connection therewith shall be subject to the supervision of the City Inspector of said City, that the public way shall be restored completely and to the entire satisfaction of and at such time as the City Inspector may determine without expense to said City; that they will safeguard by the use of barricades and red lights and such other means as may be necessary for the public safety any excavation or obstruction placed in said public way during the installation, maintenance, repair or use of same, and will at all times save the City of Vandalia free and harmless from any and all liability for damages to persons or property in any way connected with, arising out of, or incidental to the installation, maintenance and use of the granting and exercise of said license or privilege and hereby waive all claims for damages or expense in connection herewith; that they will conform to all the provisions of the Codified Ordinances of the City of Vandalia, and with such other provisions of other ordinances as may be passed by the Council which said existing or future ordinances are made part of this contract by express reference.

The following items shall be paid/posted prior to issuance of permit:

- 1) Permit Fee in the amount of \$ 27.50;
- 2) Liability insurance certificate in the amount of \$ _____ naming the City of Vandalia as insured;
- 3) Performance bond, cash, certified check* in the amount of \$ _____ to cover the actual cost of restoring the street, sidewalk, alley, or other disturbed areas in the public way or place.

*(The owner/lessee is hereby advised that the surety posted is solely for the purpose of guaranteeing that disturbed areas will be restored in conformance with City Standards. It is not for the purpose of insuring the quality of the work nor to guarantee the work for any given period of time).

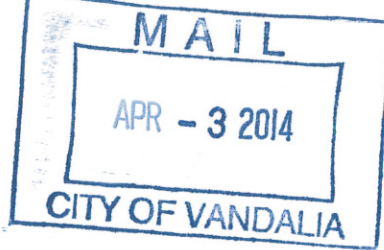

Utility Technologies International, on behalf of Vectren Energy of Ohio, is requesting permission to bore a 12" pipe under four (4) roads in Vandalia, Ohio. These bores are necessary as part of the relocation of the natural gas transmission pipeline around the Dayton International Airport. The pipe is constructed of steel, coated with fusion bonded epoxy and will have an additional coating of Powercrete (or equivalent) applied. After the installation is complete, pipeline markers will be placed on both sides of the road identifying the location of the transmission line.

Additionally, Vectren requests permission to install temporary construction access points off Corporate Center Drive, Peters Pike, and Dog Leg Road to enable access for the construction of the pipeline. These activities are all addressed in the Storm Water Pollution Prevention Plan for the project and will be protected with appropriate stormwater controls. All areas disturbed from the construction and installation of the pipeline will be restored to their pre-existing condition once the installation for the pipeline has been completed.

The locations of the bores and temporary access points are:

All conditions, restrictions, and regulations issued from your office, including location will be complied with. At no time will the governing authority, as signed below, be held responsible for damage to the facilities placed under this work order in the course of normal maintenance and repair.
