## EXECUTIVE SUMMARY

Tetra Tech, Inc. (Tetra Tech) conducted a survey of historic architecture to assist Carroll County Energy LLC (CCE) in supporting its permit application to the Ohio Power Siting Board (OPSB). This survey was undertaken in the vicinity of the proposed Carroll County Energy facility (the Facility) in Washington Township, Carroll County, Ohio, during June 2013. The OPSB rules to certify an application require the project sponsor to estimate the impact of a proposed undertaking on the “preservation and continued meaningfulness” of documented cultural resources located within five miles of the undertaking, and to develop plans to mitigate any adverse impacts upon those resources (Ohio Administrative Code 4906-13-07).

Tetra Tech conducted a literature review and historic architecture site file review of the area within five miles of the proposed Facility Site, utilizing resources available on file at the Ohio Historic Preservation Office in Columbus, Ohio, and searchable databases of the Ohio Historic Inventory, the National Park Service, the Ohio Department of Transportation, the Ohio Department of Natural Resources, and other accessible websites. The five-mile review resulted in the identification of five sites listed in the National Register of Historic Places (NRHP), no sites determined eligible for the NRHP, and no National Historic Landmarks. Tetra Tech concludes that the proposed undertaking will have no adverse impacts on documented sites, cemeteries, or parks.

Tetra Tech recommends that a finding of no adverse effect be made for all the historic properties discussed herein, as the presence of the Facility will not change the attributes of the historic properties which have qualified them to be listed in the NRHP, to be recommended as potentially NRHP-eligible, or to be listed within the Ohio Historic Inventory; or diminish the continued meaningfulness of these resources.

## 1.0 INTRODUCTION

Tetra Tech, Inc. (Tetra Tech) is assisting Carroll County Energy LLC (CCE) with permitting the proposed Carroll County Energy facility (the Facility) in Washington Township, Carroll County, Ohio (Figure 1). The proposed Facility is an approximately 700-megawatt (MW) air-cooled 2x1 natural gas-fired combined-cycle electric generating facility. The Facility, as well as a proposed electric switchyard, is proposed to be located within an approximately 77-acre parcel (the Facility Site). The Facility and Facility Site are the subjects of this report; other related elements, such as the electric transmission line interconnection and natural gas pipeline laterals, will be addressed with subsequent reports, as required.

No historic structures are located within the Facility Site; therefore, potential affect is limited to visibility from historic structures surrounding the Facility. Prior to initiating the historic architecture survey, Tetra Tech conducted a literature and file review to identify recorded architectural resources within five miles of the Facility Site, as specified by guidelines of the Ohio Power Siting Board (OPSB) rules regarding the development of electric generation facilities (Ohio Administrative Code 4906-13). Other types of cultural resources were addressed in the Phase I Archaeological Survey for Carroll County Energy (Tetra Tech, 2013). CCE anticipates seeking a United States Army Corps of Engineers Nationwide Permit for activities associated with the Facility.

This report presents the results and recommendations of background research and historic architecture field investigation. Section 2 describes background research and literature and site file reviews. Section 3 presents the research design and field methods utilized. Section 4 provides the results of the historic architecture survey. Section 5 gives conclusions and cultural resource management recommendations.

D., conducted the background research, developed the research design, undertook the fieldwork, and authored this report. Dr. Sexton meets the Secretary of the Interior's Professional Qualification Standards for Architectural History.

## 2.0 BACKGROUND RESEARCH

### 2.1 Project Setting

The Survey Area is defined by OPSB rules as a five-mile radius surrounding the Facility Site. The Survey Area is hilly, characterized by varied topography and a mix of settlement patterns. The center of the Survey Area, closest to the Facility Site, is sparsely populated land with a mix of woodland and cleared agricultural fields. Utility corridors, such as overhead electric transmission lines and underground natural gas pipelines, extend through the area.

Carrollton, the county seat for Carroll County, sits approximately 2.5 miles to the southeast of the Facility. With a historic town square at its center, Carrollton has the largest concentration of buildings and population in the survey area. Its roads are laid out along a modified grid, and its housing and commercial buildings represent periods from settlement in the beginning of the nineteenth century through today.

In general, the land within the Study Area retains a sense of historic mixed-use patterns. However, in some locations, such as at the western edge of the five-mile radius in Harrison Township, new suburban-style developments can be seen.

### 2.2 Historic Context (AD 1600-1820)<sup>1</sup>

The earliest historic references to Ohio indicate extensive raiding by the Iroquois Nation into the region south of Lake Erie, which wrested control from the Erie People around 1650 (Hunter 1978:588). The Iroquois utilized the area between Lake Erie and the Ohio River for hunting, especially in their pursuit of deer hides for their lucrative trade with the French and English. Contacts between Native Americans and Europeans can be confirmed by the mid-seventeenth century in the Ohio valley, but within interior regions these first encounters occurred decades later (Hunter 1978:588). Initially of a limited nature, interaction between the two groups intensified through the eighteenth century. Taking advantage of the unsettled nature of affairs during the protracted period of French and English conflict, groups of Wyandot and Miami entered the region from the north as Seneca, Delaware, and Shawnee made their way there from the east. After the American Revolution, the United States forced a series of treaties upon Native Americans, pushing them out of the Ohio valley, and in 1842, when the Wyandot surrendered their final claim to land around Upper Sandusky, Ohio was emptied of its Native American inhabitants (Hunter 1978:593).

Initial settlement of the region by Euro-Americans occurred around 1800 in the Townships of Washington and Lee, after the threat of hostilities between settlers and Native Americans in the Ohio Valley had been eliminated. Tradition suggests that the first settler may have been Jesse Palmer, who settled in Washington Township along what is now known as Palmer's Fork (Lane 2003:25). The first village in the area, Centreville, was laid out in 1815 and would later be known as Carrollton. In 1832, the state legislature approved the creation of Carroll County from parts of five surrounding counties with Carrollton serving as county seat. Both Carroll County and the Village of Carrollton were named after Charles Carroll, at the time the last surviving signer of the Declaration of Independence (Eckley and Perry 1921:12-19).

Situated between the Ohio River and Lake Erie, Carroll County boosters supported the construction of the Ohio Canal system connecting the two waterways. Begun in 1825 and completed in 1850, the connector Sandy and Beaver Canal followed Sandy Creek from Minerva through Malvern in the northwestern part of the county, but was abandoned in 1852 due to engineering difficulties and economic competition from railroads (Eckley and Perry 1921:18).

While agriculture was (and remains) the principal occupation of county residents, economic take-off was achieved in Carroll County with the introduction of rail lines. The Cleveland & Pittsburgh Railroad built its Tuscarawas Branch between Minerva and Malvern in 1854, and the same year the Carroll County Railroad completed a line through Carrollton. The railroads allowed the coal deposits in the county to be efficiently exploited and provided a means for farmers to market their produce to the growing urban centers on Lake Erie and along the Ohio River (Eckley and Perry 1921:19).

By the turn of the twentieth century Carrollton had become a regional manufacturing center, with rubber, aluminum, brick, and pottery works. Most notable of these industries was the Carrollton Pottery Company which in 1920 employed 350 workers at its nine kilns, producing a variety of semi-porcelain wares (Eckley and Perry 1921:143). Despite these employment opportunities, Carroll County's population declined and stagnated for more than a century. Not until 1950 did the county population exceed the 1840 level of 18,100 persons (<http://www.carrollcountyohio.com/history/>). The 2010 census enumerated approximately 28,800 residents. The principal agricultural products in recent years have been hay, corn, soybeans, wheat, and milk (USDA 2007). Recent advances in drilling technology have enabled the Utica shale formation to be exploited for its oil and natural gas deposits. Carroll County leads Ohio in the number of drill permits and oil and natural gas wells drilled.

### 2.3 Recorded Landmarks

The OPSB has expressed in its “Rules for Certification for Electric Generating Facilities” that the presence of registered landmarks of historic, religious, archaeological, scenic, natural or other cultural significance within the vicinity of a project area and the mitigation of adverse impacts upon these resources are factors in its approval process for developers’ permit applications (Ohio Administrative Code 4906-13-07). The OPSB defines registered landmarks as any historic districts, archaeological sites, buildings, structures, or objects that have been listed by or that might be eligible for listing by the National Park Service’s National Registry of Natural Landmarks (NRNL), the Ohio Historical Society, or the Ohio Department of Natural Resources (ODNR). OPSB rules require developers to generate maps at 1:24,000 scale depicting the locations of registered landmarks within five miles (eight kilometers) of the proposed undertaking (Figure 2).

A review of the online cultural resources database maintained by Ohio Historic Preservation Office (OHPO) revealed the presence of five previously-listed National Register of Historic Places (NRHP) properties within the five-mile OPSB study area (Table 1); all of them are more than 2.5 miles from the Facility Site. The Ohio Historical Inventory (OHI) lists 158 resources, including the five NRHP listed properties, within five miles of the Facility Site (Table 2). As can be seen from that table, only five resources are located within two miles of the Facility Site, with many located in the village of Carrollton.

### 3.0 HISTORIC ARCHITECTURE FIELD SURVEY

#### 3.1 Research Design

The objective of this survey design was to develop a framework for a reconnaissance survey to determine the potential for resources listed in the NRHP, the OHI data base, and those newly recommended as potentially NRHP-eligible to be affected by the construction of the Facility. The first step in this process was the definition of the Area of Potential Effect (APE). As no historic structures are to be directly affected in the construction of the Facility, the primary potential effect is visual. Because of that, Tetra Tech defined the APE as all areas within five miles of the Facility Site that a topography-only<sup>3</sup> computer generated viewshed model indicated would potentially have a view of part or all of the Facility (Figure 3).

Since the Facility is composed of elements of distinctly different heights and character, the viewshed model shows two overlapping viewsheds: a larger area indicating locations from which the two 275-foot tall stacks may be visible, and a smaller viewshed indicating locations from which the tallest buildings associated with the Facility (air cooled condenser and heat recovery steam generator, each at 110 feet tall) may be visible. For the purposes of analysis the larger, more inclusive area of visibility was used to define the APE as the basis for field work.

Because the visual impact of the Facility diminishes the further one moves from it, the APE was divided into two distance zones. The size of the distance zone closest to the Facility is modeled on the APE for cell towers included in the Nationwide Programmatic Agreement for Review of Effects on Historic Properties for Certain Undertakings Approved by the Federal Communications Commission (the NPA). The NPA states:

*the presumed APE for visual effects for construction of new Facilities is the area from which the Tower will be visible: a. Within a half mile from the tower site if the proposed Tower is 200 feet or less in overall height; b. Within  $\frac{3}{4}$  of a mile from the tower site if the proposed Tower is more than 200 but no more than 400 feet in overall height; or c. Within 1  $\frac{1}{2}$  miles from the proposed tower site if the proposed Tower is more than 400 feet in overall height.*

As the Facility will consist of buildings of roughly 110 feet in height with two stacks of 275 feet in height the APE has been divided into two sections: up to 0.75 mile from the Facility Site and from 0.75 to five miles from the Facility Site.

#### 3.2 Field Methods

All accessible public roads within the APE were driven by Tetra Tech's architectural historian. Along the roads, historic structures were observed and evaluated. Depending on the distance from the Facility Site, work followed one of two approaches, as described in the following sections.

---

<sup>3</sup> Note that the influence of intervening structures and vegetation would be expected to further considerably reduce visibility from some locations.

### 3.2.1 Reconnaissance Survey Up to 0.75 mile from the Facility Site

In this distance zone, Tetra Tech undertook a comprehensive reconnaissance survey to review all previously documented historic buildings and document all previously unrecorded historic buildings located within 0.75 miles of the Facility Site. No previously recorded NRHP or OHI buildings existed within this distance zone.

Tetra Tech followed the standard practice of defining unrecorded historic buildings as those buildings style-dated in the field as 50 years old or older. Locational data were recorded from the public right-of-way using a Global Positioning System (GPS) mounted on a digital Single Lens Reflex (SLR) camera. The GPS unit, called a “hotshoe geotagger,” collected locational data at the time photographs were taken; software was later used to associate the positional information with the photographs. Field identification and subsequent analysis utilized OHPO and National Park Service technical guidance and primary source historic documents wherever available. Most useful in this process was the use of a georeferenced version of the 1959 United States Geological Survey (USGS) Map of the Carrollton Quadrangle. This map provided evidence of whether buildings had existed in the location of current buildings at that time.

Tetra Tech recorded data about 15 previously unrecorded historic resources on the OHPO Section 106 Project Review Summary Form (PRSF), including a recommendation about whether each previously unrecorded property is potentially NRHP-eligible (see Appendix A for the OHPO PRSF). The location of these properties is shown on Figure 4. Each of the 15 previously unrecorded historic resources is described in Section 4.1.

### 3.2.2 Reconnaissance Survey from 0.75 mile to 5.0 Miles from the Facility Site

Within this distance from the Facility, visibility effects are limited not only by intervening topography but by distance. Therefore, in this distance zone Tetra Tech undertook a focused reconnaissance survey that focused on resources that had been previously documented in the NRHP or the OHI to assess their significance and the potential effect of the Facility on their continued meaningfulness. The results of this assessment are discussed in Section 4.2.



## 4.0 RESULTS OF FIELD INVESTIGATION

### 4.1 *Reconnaissance Survey Up to 0.75 mile from the Facility Site*

The survey identified no properties previously listed in the NRHP or the OHI within the portion of the APE lying within 0.75 miles of the Facility Site. Fifteen previously unrecorded properties were documented using the OHPO Section 106 Project Review Summary Form and are described below.

Three roads cross this section of the APE: Route 9 (Kensington Road) in the western half; Mobile Road runs from just west of the midline at the bottom of the zone to just east of the midline at the top; and Andora Road runs northeast through the southeastern quadrant of the zone. A fourth road, Cobbler Road, is located just north of the zone; one of the properties is located off of Cobbler Road. Figure 4 illustrates the location of each property described below.

None of the aforementioned properties is recommended as potentially eligible to the NRHP. The Facility will introduce a modern power generating facility into an already changed landscape. It will not be the first modern intrusion into the area: new houses have been constructed throughout the area; large, modern buildings including a school, dog pound, and office building have been constructed in the northwest quadrant (across the road from the County Home); and two transmission lines and one pipeline corridor cross the area.

#### **Tt1 – 2202 Kensington Road NE – Carroll County Golden Age Retreat (1954)**

(Photographs 1 – 8)

The Carroll County Golden Age Retreat (formerly the County Home) is a complex of six buildings: a main brick building with Modern Movements details, five agricultural outbuildings (three barns, a shed, and a silo) and a subterranean brick and terra cotta building. According to the facility's web site, the property was purchased in 1867; by 1874 the County Infirmary appears in this general area on the Map of Washington Township in the County Atlas. The current main building is the second from the twentieth century on the site, replacing one constructed in 1937 as the County Hospital. The residents originally farmed the surrounding land; this practice ended in 1967. The main building has had its windows replaced and modern pent roofs added to its façade.

#### **Tt2 – 2073 Kensington Road NE (ca. 1900)**

(Photograph 9)

Tt2 is set far back from the road; only a small portion of it is visible from the public right-of-way. A building is shown in this location on the 1912 USGS Map of the area; no buildings are in this location on the 1874 County Atlas.

#### **Tt3 – Jenkins Farm – 2061 Kensington Road NE (ca. 1920)**

(Photographs 10-16)

The Jenkins Farm is a complex of ten buildings and structures on both sides of the road. The main house is an American four-square building with a hipped roof and a full-width front porch. It appears to have new cladding and windows; the window surrounds may be historic. The farm buildings are a mix of modern and historic, with a timber-framed barn, two modern barns, an open shed, two silos, and three grain bins.

**Tt4 – 1298 Kensington Road NE (ca. 1970)**

(Photographs 17 – 18)

Tt4 is a one-story, ranch house with a one-car detached garage. The building may be a manufactured house; it is included in the survey because a building was located on this site on the 1959 USGS Map of the Carrollton Quadrangle. It may not be this house.

**Tt5 – Little Farm – 2276 Mobile Road NE (ca. 1900)**

(Photographs 19 – 27)

The Little Farm is a complex of seven buildings, two silos, and three grain storage bins. Buildings have been located here since prior to 1874, when it appears as the farm and orchard of A. Adams. As the current main house is an American four-square building with a hipped roof and an enclosed front porch, it is likely the second house on the site. The building has been covered in modern siding and some of the windows may have been replaced. The outbuildings are a mix of historic and modern structures, with three older barns, a historic chicken coop, and two modern buildings.

**Tt6 – Rummell House – 2120 Mobile Road NE (ca. 1912)**

(Photograph 28)

Tt6 is an upright and wing house with an unattached, garage. It has been clad in modern siding over earlier narrow clapboards and the porch has been rebuilt. The garage is a more recent, concrete block building. A building is in this location on the 1912 USGS Map of the area.

**Tt7 – No Structure Observed from Mobile Road**

(No photograph)

Though a building in this location is indicated on the 1912 and 1959 USGS maps, currently no building is visible from the public right-of-way and no mailbox is located at the end of the drive.

**Tt8 – House – Mobile Road**

(Photograph 29)

The front of this property was screened from view; the best view is of the rear from Andora Road. The property contains a one-story brick building with a side gable form and a detached garage. No building was in this location at the time of the 1912 USGS Map; one was here by the time of the 1959 USGS map.

**Tt9 – Residence and Barn – Mobile Road**

(No photograph)

Tt9 is not visible from the public right-of-way. A building appears in this location in the 1874 County Atlas and the 1912 and 1959 USGS maps for the area. Recent aerial photos show a small building with dormers on the front and back slopes of a side gable roof. A larger building, perhaps a barn is located to the southeast of this building. The barn does not appear on the USGS map for 1959 (although other barns in the area do), suggesting it may be modern.

**Tt10 (ca. 1870 and later) – House, Barn and Outbuildings – Mobile Road**

(Photographs 30 – 32)

Tt10 is a historic, English-style bank barn associated with a modern, gambrel roofed house. The barn has a modern standing seam, metal roof, modern doors and tracks, and an open lean-to on the north end for the storage of equipment. A lean-to was also added at the rear. This property was the estate of B. Kuhn in 1874. The house is far more recent; the barn may be from the second half of the nineteenth century.

**Tt11 (ca. 1870 and later) – Farmstead**

(Photographs 33 – 40)

Tt11 is a large farmstead with six outbuildings. The main house is a one-story, side gable building. It has been reclad with aluminum siding and the windows are replaced. The largest barn, which overlooks a

pond, has a T-shaped plan and a peaked roof. Additional buildings include a smaller barn, a large garage, several sheds, and a building whose roof hatches suggest that it may be a granary. The farmstead appears on the 1874 County Atlas as the property of G. Summerwell. Although the house appears not to be that old, some of the outbuildings may be.

**Tt12 – (ca. 1950) – 1216 Andora Road**

(Photograph 41)

1216 Andora Road is a one-story ranch house clad in aluminum siding and stone veneer. A detached 2-story garage sits to the north of the building. A structure appears in this location on the 1959 USGS map; it is likely this building.

**Tt13 (ca. 1870) – Farmstead – Andora Road**

(Photographs 42 – 44)

Tt13 is a farmstead set far back from the road and containing three buildings: a house, a bank barn with lean-to, and a Quonset barn. The main house is constructed of terra cotta blocks or oversized bricks, has a standing seam metal roof, and modern windows. An ell to the south of the main block appears to clad in vinyl or aluminum siding. The building appears on the 1874 County Atlas as the farm of Fred Nape; it also appears on the 1912 USGS map for the area.

**Tt14 – (ca. 1950) – 1124 Andora Road**

(Photographs 45 – 46)

1124 Andora Road is a one-story, ranch house with a side-gable form and a cross gable at the north end. A detached garage or shed is located south of the property.

**Tt15 – (ca. 1865) – Watts Farm – Cobbler Road**

(Photograph 47)

Watts Farm is a large farmstead set far back from the road. The main building is an Italianate house with a hipped roof and nine outbuildings, including three modern barns. The building appears on the 1874 county atlas as the home of J. Myers; it also appears on the 1912 USGS map of the area. A building in this location is visible on the 1959 USGS map for the area.

**4.2 Focused Survey From 0.75-5.0 miles from the Facility Site**

In this distance zone Tetra Tech undertook a focused reconnaissance survey that examined all resources that fell within the APE and had been previously documented in the NRHP or the OHI to assess their significance and the potential effect of the Facility on their continued meaningfulness (Figure 5). Four of the five NRHP-listed properties within five miles of the Facility Site fell within the APE; the fifth property was in an area of no visibility and was consequently outside the APE (Table 1). All of the NRHP-listed properties were more than 2.5 miles from the Facility.

- Henry and Mary Pottorf House and Farmstead – 4971 Meter Road, Mechanicstown (1858) – Photograph 48 – The Pottorf House and Farmstead is a well preserved farmstead that includes a two-story brick I-house (1858) with Greek Revival details, a wood-frame bank barn (1914), two milk houses (1920 and 1940) and a well. The Pottorf House and Farmstead is located more than 4.7 miles to the northeast of the Facility. It is situated on the north side of the road, so that when one views the resources from the public right-of-way, the Facility will be behind the viewer.
- Van Horn Building/Saltzman Drugstore – Corner of W. Main Street and N. Lisbon Street, Carrollton (1829) – Photograph 49 – The Van Horn building is a three-story Italianate commercial building. It sits in a commanding location at the northern end of the town square. The Van Horn Building is

located more than 2.7 miles southwest of the Facility. The building has two main facades, facing east and south. While viewing the southwest corner of the building from Courthouse Square there is the possibility that the Facility might appear in the background of the view. However, it seems likely that the nearby buildings will screen the Facility from the viewer; if they do not, the Facility will be simply one of many modern elements in the view.

- Carroll County Courthouse – South Lisbon Street, Carrollton (1885) – Photograph 49 – The Carroll County Courthouse is a two-story Romanesque Revival building with a central tower and a raised ground floor. The Carroll County Courthouse is located more than 2.7 miles to the south of the Facility. When one views the main façade of the building from the public right-of-way the Facility will be located off to one side. While it might be possible to see the Facility on the periphery it is likely that adjacent buildings on Courthouse Square (as well as on neighboring streets) will screen the most, if not all, of the Facility from view.
- Daniel McCook House – 2<sup>nd</sup> Street, Carrollton (1829) – Photograph 50 – The Daniel McCook House is a two-story, Federal style brick building located at the south end of the public square. In addition to being a well-preserved example of a Federal style building, it is associated with the “Fighting McCooks,” 14 of whose members fought in the Civil War. An Ohio Historical Marker is also located at the site. The McCook House is located more than 2.8 miles to the southwest of the Facility. The main façade of the building faces north, so that when one looks at it the Facility is located behind the viewer. In addition, nearby buildings on Courthouse Square (as well as on neighboring streets) will screen the most, if not all, of the Facility from view.

All 158 properties previously listed in the OHI and within five miles of the Facility Site were located in this zone. Of these 158 properties, 94 fell within the potential viewshed. The computer model indicates that the Project would not be visible from the other 64 buildings. Of the 94 buildings with a potential view, 24 are anticipated to see stacktop views only, while the remainder indicates potential visibility of a portion of the tallest structures.

Six of the structures are located within the surrounding countryside. While the topography-only viewshed model suggests that the Facility may be visible from some sites within this portion of the APE, it will not be the only modern intrusion into the landscape. Distance (greater than 0.75 mile) is anticipated to significantly diminish the impact of any potential Facility view. Vegetation, particularly during leaf-on conditions, is also anticipated to contribute to visual screening.

The vast majority (88 buildings) of the buildings which the computer model shows as likely to have a view of the Facility are located in downtown Carrollton. Views from structures located within Carrollton, in addition to being quite distant, also have the potential to be blocked by intervening buildings in this more densely developed area. Where the Facility may be able to be seen at that distance, the Facility will simply be another distant feature on an already crowded horizon.

## 5.0 RECOMMENDATIONS

Tetra Tech concludes that the proposed undertaking will not adversely affect the four NRHP-listed properties, 94 OHI properties (including the 4 NRHP properties), or 15 newly identified historic properties within the APE. Tetra Tech recommends that a finding of no adverse effect be made for all the historic properties discussed herein, as the presence of the Facility will not change the attributes of the historic properties which have made them historically significant, diminish their continued meaningfulness, or represent a major modification to the setting of these properties.

within .75 miles of the Facility Site

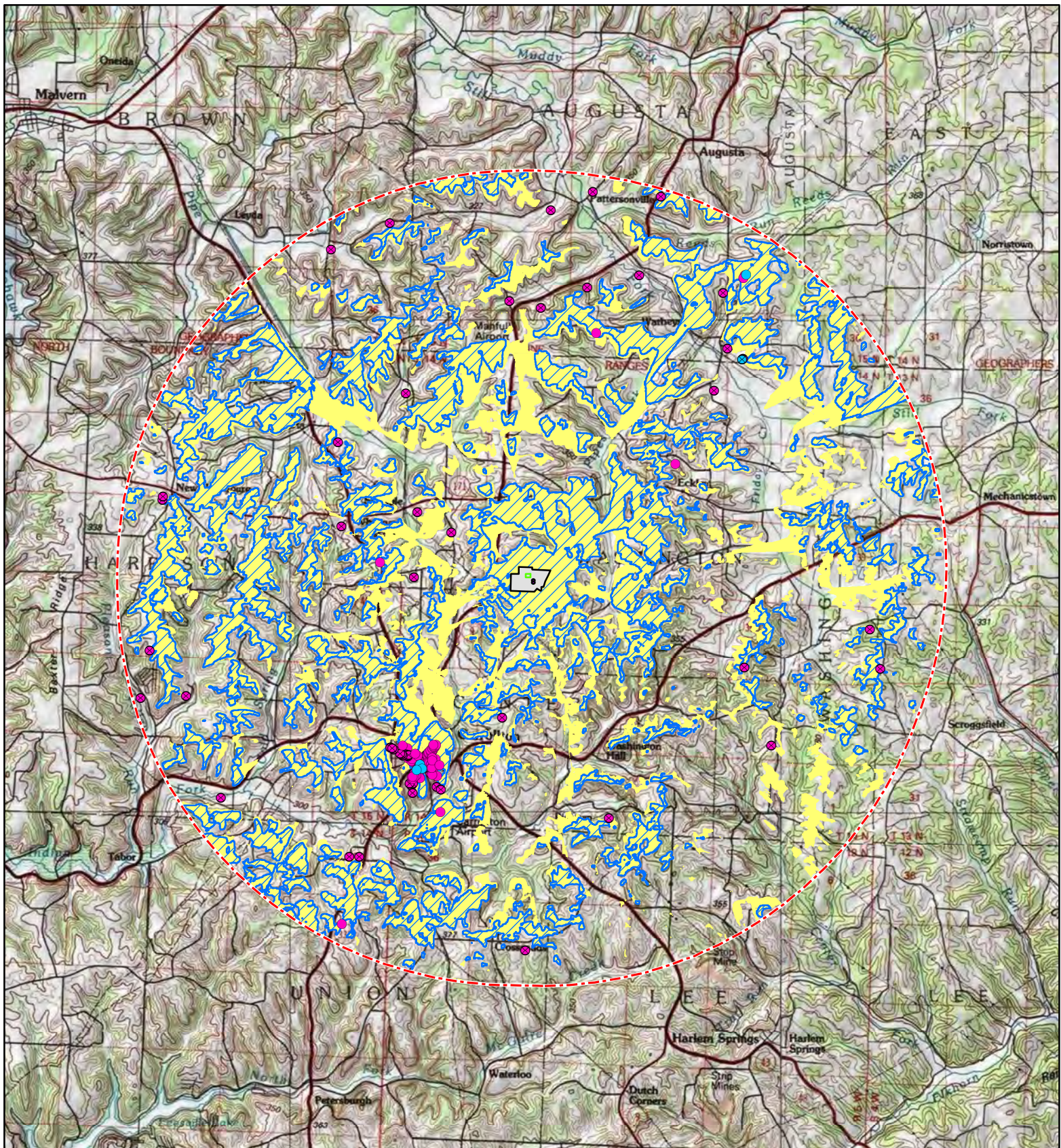

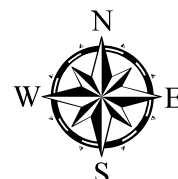
