MEMORANDUM IN SUPPORT

As a competitive retail electric service provider and electric services company (as defined

in Ohio Rev. Code 4928.01(A)(4) and 4928.01(A)(9), respectively) Censtar is required to file, by

April 15th of each year, an annual alternative energy portfolio status report. Ohio Admin. Code

4901:1-40-02(B) provides: "[t]he commission may, upon an application or a motion filed by a

party, waive any requirement of this chapter, other than a requirement mandated by statute, for

good cause shown." The April 15th filing deadline is imposed by virtue of the Commission's

rules in Admin. Code 4901:1-40 et seq., not any statutory provision contained in the

corresponding Revised Code Section 4928.64. Accordingly, the Commission has discretion to

waive the April 15th filing deadline and grant Censtar an extension to file its status report by May

15th.

Good cause exists to grant Censtar an extension to file its status report. Although Censtar

intended to timely file this report, an oversight resulted in the company's inability to complete a

timely filing. In addition, as the 2013 is the first calendar year during which Censtar has been

required to gather and compile the relevant information, Censtar is finding that gathering said

information is taking longer than expected. Consequently, Censtar submits that it is in need of

an extension until May 15, 2014, to fully comply with its alternative energy status portfolio

reporting obligations.
