
2. Ms. Shadrick neither resides in nor is regularly employed at an office in the State of Ohio;



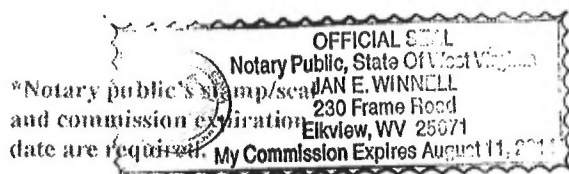
