

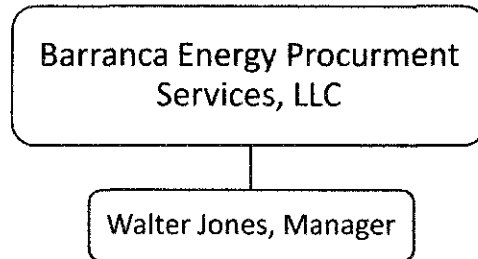

On April 18, 2014 the Docketing Division received a certification application for Aggregators/Power Brokers in case 14-708-EL-AGG with your name listed as the Applicants "Legal Name".
