MOTION TO CURE LATE PUBLICATION OF ONE PUBLIC NOTICE OF PROJECT

Pursuant to Rev. Code §4906.06(D) and Admin. Code §4906-5-09(C), Applicant American Transmission Systems, Incorporated (“ATSI”), requests that the Ohio Power Siting Board (“Board”) issue an order curing a minor delay in publication of one of the Public Notices for Second Amendment to the East Springfield-London-Tangy Transmission Line. Pursuant to the Board’s interim requirements for the filing of Letters of Notification, as established in the Second Finding and Order issued on December 17, 2012 in Case No. 12-1981-GE-BRO, Applicant was required to provide for publication of the Public Notice of the Amendment Application in this case within 7 days of filing with the Board. Due to the length of this Project, the Applicant has published the required Public Notice in 6 publications in the Project Area. All of the Public Notices were published within seven days of the filing date of April 24, 2014, with the exception of the notice in The Plain City Advocate. Applicant requests that the Board accept as timely the publication of the Public Notice in The Plan City Advocate on May 3, 2014.

The Plain City Advocate is a Saturday only publication, and the Public Notice was submitted to the paper on the date of filing, April 24, 2014, which was past the deadline for publication on April 26, 2014. The first date for publication after the submittal of the Public Notice was May 3, 2014. Since the Public Notice was timely published in 5 other publications,

and was published at the earliest possible date in the Plain City Advocate, Applicant requests that the Board issue an order confirming that publication in the Plain City Advocate for this Project was adequate to ensure sufficient, timely and effective public notice of the Project. Applicant will file traditional proof of publications for all public notices once they are received.
