The East Ohio Gas Company d/b/a Dominion East Ohio (DEO) filed its application in this case on December 19, 2013. On January 13, 2014, the Commission issued a procedural entry, in which it called for the filing of comments by April 24 and reply comments by May 9. On April 24, the Commission's Staff filed comments "recommend[ing] that the Commission approve DEO's Application as filed." (*Id.* at 9.) No other party intervened or filed comments.
