


## MEMORANDUM IN SUPPORT

In accordance with Rule 4901-1-25, Ohio Adm. Code, Columbia Gas of Ohio, Inc. ("Columbia") respectfully requests that the Attorney Examiner sign and issue the subpoenas attached as Exhibits A and B. Respectively, the subpoenas direct Andrew J. Sonderman to appear and give testimony at a trial deposition on June 10, 2014 (Ex. A), and at the hearing of this case on June 24, 2014 (Ex. B).

There is good cause for issuance of the requested subpoenas. This case involves a dispute between Columbia and Suburban Natural Gas Company regarding a Stipulation approved by the Commission in *In re Self Complaint of Columbia Gas of Ohio, Inc.*, Case No. 93-1569-GA-SLF. 


