

**MEMORANDUM IN SUPPORT**

Now comes One Source Energy Group, LL ("the Company"), by and through counsel, seeking re-certification as an aggregator and power broker in the State of Ohio, pursuant to ADM Code Rule 4901-I-24(D). The Company's original application for certification was approved by the Public Utilities Commission of Ohio ("PUCO or Commission") on May 21, 2013. The renewal application was required to be filed at least thirty (30) days prior to the expiration, May 21, 2014; however, the application was not filed until May 19, 2014. Pursuant to Ohio Adm. MEMORANDUM IN SUPPORT


ONE SOURCE ENERGY GROUP, LLC, ("the Company") submitted its original application for certification, which was approved by the Public Utilities Commission of Ohio ("PUCO" or "Commission") on May 21, 2013. The renewal application was required to be filed at least thirty (30) days prior to the expiration, or by May 21, 2014. However, due to a clerical error, the application was not filed until May 19, 2014.

(A) No less than thirty and no more than sixty calendar days prior to the expiration date indicated on the competitive retail electric service provider's certificate, the provider shall file an application with the commission for certification renewal on forms supplied by the commission. If the provider files such a renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty calendar days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion.

The Company respectfully requests that the commission extend its current certification, for an additional thirty (30) days, or until June 21, 2014, to allow sufficient time for review and approval of the Company's renewal certification application.

WHEREFORE, for the above stated reasons, ONE SOURCE ENERGY GROUP, LLC, respectfully requests that the commission grant its motion to extend, for an additional thirty (30) calendar days, or until June 21, 2014.
