## **ENTRY**

The attorney examiner finds:

- (1) Staff served a notice of preliminary determination upon LMD Integrated Logistic Services, Inc. (Respondent) in accordance with Ohio Adm.Code 4901:2-7-12, alleging violations of the Commission's transportation regulations.
- (2) On April 16, 2014, Respondent filed a request for an administrative hearing in accordance with Ohio Adm.Code 4901:2-7-13.
- (3) A prehearing conference was held on May 19, 2014; however, the parties were unable to settle this matter. Accordingly a hearing should be scheduled on June 26, 2014, at 1:00 p.m., at the offices of the Commission, 180 East Broad Street, 11th floor, Hearing Room 11-D, Columbus, Ohio 43215-3793.
- (4) Ohio Adm.Code 4901-1-08, provides that corporations must be represented by an attorney-at-law.
- (5) Ohio Adm.Code 4901:2-7-14(E), provides that a respondent who has requested an administrative hearing and fails to participate in the hearing proceeding shall be in default. The rule additionally states that a respondent in default shall be deemed to have admitted the occurrence of the violation and waived all further right to contest liability to the state for the forfeiture described in the notice.
- (6) At the hearing, Staff must prove, by the preponderance of the evidence, that Respondent committed the alleged violations, pursuant to Ohio Adm.Code 4901:2-7-20(A).
