#### CONSTRUCTION NOTICE BROOKSIDE-HOWARD 138 kV TRANSMISSION LINE RECONDUCTORING PROJECT

The following information is being provided in accordance with the procedures in Ohio Administrative Code Section 4906-11-02: <u>Construction Notice Requirements</u> of the Rules and Regulations of the Ohio Power Siting Board.

#### 4906-11-02 (B): Information Requirements

#### 4906-11-02 (B) (1): Name of the Project

Name of Project:

Brookside-Howard 138 kV Transmission Line

Reconductoring Project ("Project").

#### 4906-11-02 (B) (2) (a): Brief Description of Project

In this Project, American Transmission Systems, Incorporated ("ATSI"), a FirstEnergy company, is proposing to reconductor an approximately 14 mile long section of the existing Brookside-Howard 138 kV Transmission Line. The Project will replace the existing 336.4 kcmil 26/7 ACSR conductor with 336.4 kcmil 26/7 ACSS conductor. The Project begins at the ATSI owned Brookside Substation and extends for approximately 14 miles along the existing Brookside-Howard 138 kV Transmission Line to an interconnection with American Electric Power ("AEP"). AEP owns the approximately 8 mile long portion of the Brookside-Howard 138 kV Transmission Line extending to the existing Howard Substation.

The general location of the Project is shown in Exhibit 1. The general layout is shown in Exhibit 2a through 2b. The Brookside-Howard 138 kV Transmission Line associated with this Project will be owned and operated by ATSI. The Project will be located in the City of Ashland, Montgomery Township, and Milton Township in Ashland County, Ohio, and Weller Township and Franklin Township in Richland County, Ohio.

#### 4906-11-02 (B) (2) (b): Construction Notice Requirements

The Project meets the requirements for a Construction Notice because the Project is within the types of project defined by Item (3) of the Interim Application Requirement Matrix for Electric Power Transmission Lines in the Finding and Order issued on September 4, 2012 in Case No. 12-1981-GE-BRO, which modified Appendix A of Rule 4906-1-01 of the Ohio Administrative Code. This item states:

(3) Replacing conductors on existing structures with larger or bundled conductors.

The proposed Project replaces approximately 14 miles of conductor on the Brookside-Howard 138 kV Transmission Line.

#### 4906-11-02 (B) (3): Need for the Project

The project is needed to address thermal overloads on the ATSI transmission system due to generation retirements, and to provide improved voltage support to the region. The existing 336.4 kcmil 26/7 ACSR conductor has a summer emergency rating of 179 MVA. This line will become overloaded for various system contingencies, resulting in the need to de-energize the circuit. For example, during the common tower line outage of Galion – Leaside 138kV and Galion – Longview 138kV, the Howard – Brookside 138kV line loads to 187 MVA, or 108% of the summer emergency rating during summer peak conditions. After the Project has been completed, the new summer normal line rating will be 252 MVA and the new summer emergency rating will be 291 MVA.

#### 4906-11-02 (B) (4): Construction Schedule

Construction of the project is expected to begin as early as September 15, 2014 and be completed by May 31, 2015.

#### 4906-11-02 (B) (7): Area Map

Exhibit 1 depicts the general location of the Project. This exhibit provides a partial copy of the United States Geologic Survey, Mansfield North, Pavonia, and Ashland South Ohio Quads. To locate and view the project site from the Columbus, Ohio area, travel to the Brookside Substation by merging onto I-71North toward Cleveland and traveling for approximately 79 miles. Take exit 186 for US-250 towards

Ashland/Wooster. At the bottom of the exit ramp, take a left onto US-250 W. Travel for approximately 1.7 miles then turn right to merger onto US-250 W/US-42 N toward Norwalk/Medina. Travel for approximately half a mile then turn left onto Middle Rowsburg Road. After approximately 0.2 mile, the Brookside Substation will be on the left.
