ENTRY

The attorney examiner finds:

- On May 17, 2013, Suburban Natural Gas Company (Suburban) filed this complaint alleging that Columbia Gas of Ohio, Inc. (Columbia) is providing gas to residential customers in violation of a stipulation approved by the Commission in *In re Self Complaint of Columbia Gas of Ohio, Inc.*, Case No. 93-1569-GA-SLF, et al., Finding and Order (Jan. 18, 1996).
- (2) On June 10, 2013, Columbia filed an answer to the complaint generally denying the material allegations of the complaint and stating that the complainant failed to state reasonable grounds for complaint.
- (3) By Entry issued November 27, 2013, the attorney examiner, inter alia, scheduled a hearing for June 10, 2014, and established the procedural schedule. By Entry issued May 12, 2014, the attorney examiner granted a request for continuance and rescheduled the hearing for June 24, 2014.
- (4) On May 29, 2014, Suburban filed an Agreed Motion for Indefinite Continuance of Hearing and Suspension of Procedural Schedule (Agreed Motion). In the Agreed Motion, Suburban states that, due to the unavailability of its witness, it requests an indefinite continuance of the hearing, suspension of the existing procedural schedule, and postponement of Columbia's prehearing depositions. Suburban states that Columbia has agreed to this request.

(5) Upon review, the attorney examiner finds the request for an indefinite continuance, suspended procedural schedule, and postponement of Columbia's pre-hearing deposition is reasonable and should be granted. A new hearing date will be set by subsequent entry. Suburban should file bi-monthly updates on the status of this matter and advise the attorney examiner at the point in time when it is ready to proceed.

It is, therefore,

ORDERED, That Suburban's Agreed Motion is granted and the hearing is continued until a date set by subsequent entry, the existing procedural schedule is suspended, and Columbia's prehearing depositions are postponed. It is, further,

ORDERED, That Suburban file bi-monthly updates on the status of this matter and advise the attorney examiner at the point in time when it is ready to proceed. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
