On March 17, 2014, the Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need subject to a number of conditions.

Condition No. 27 of the Board's Order requires the following:

## Vectren shall continue coordination with the FAA for approval, and provide Staff with the results of the coordination.

In compliance with Condition No. 27 of the Board's Opinion, Order, and Certificate, attached for filing is an e-mail exchange confirming that the installation of the underground pipeline will not interfere with any operations of the radars, and that Vectren may proceed with construction provided several conditions are met.

Michael,

Per our previous conversations and the attached control line drawing, the gas pipe line is being installed going underneath the access road on the north side of the radar site and then along the west side of the radar site, but not within the confines of the gravel & paved surfaces immediately around the ASR-9/MODES site. As I understand the site layout and as shown on the attached drawing, the power and telephone companies have easements with cables going into our site from along Old Springfield Road and the access road to the facility buildings and antenna towers. Also, all of our FAA field cables enter the site from the runway going to the hand hole on the north side of the gravel area then into the radar building. As shown in the drawing, the proposed route will in the immediate vicinity of utilities, but will not be near the FAA cable route.

The installation of the underground pipeline will not interfere with any operations of the radars as long as the following conditions are met

1. Any cranes or tall equipment are kept well below the height of the antennas.

2. The pipeline is kept outside of the gravel/paved area of the ASR-9/MODES site.

3. The pipe line installation company does proper notification and coordination with the telecom and power utilities that provide services to the radar site. Boring or trenching thru either of these companies' cables will result in loss of radar data to Air Traffic. The FAA is not liable for any damage to the utility lines.
