DUKE ENERGY OHIO'S MEMORANDUM CONTRA MOTION TO
ESTABLISH PROTECTIVE AGREEMENT**

The Ohio Energy Group ("OEG") files its Reply to Duke Energy Ohio's Memorandum Contra as follows.

Duke's proposed Protective Agreement is so onerous that it is tantamount to the utility refusing to provide confidential information. It is likely that no intervener will be able to sign Duke's proposed Agreement, if for no other reason than it subjects a party to a \$1 million penalty for the inadvertent disclosure of documents Duke unilaterally deems confidential. Unless the Commission steps in so that an orderly proceeding can be conducted consistent with past practices, then the due process rights of the parties will be threatened and the integrity of the Commission process will be compromised.
