

From 1995 to 1999 Michael Marlowe was a Certified Financial Manager at Merrill Lynch. With an emphasis on new business development in small to mid-sized markets, he simultaneously steered sales and marketing efforts and focused on reviving poor and/or inactive client relationships. He graduated from a 2-year Merrill Lynch Professional Development Program in top 20% on national class with \$12 million under management.

After his time at Merrill Lynch, Michael became an Associate Vice President at Morgan Stanley from 1999 to 2003. There he orchestrated and executed comprehensive sales and marketing initiatives while simultaneously acting on investment analysis. He was a member of a team that included four advisors and two support staff that managed over \$180 million, and also served as primary and secondary contact, managing over 300 client relationships. During his tenure, Michael played a pivotal role in sales and marketing, new business development, and relationship management resulting in increased managed assets from \$120 million to \$180 million and increased personal assets under management from \$12 million to \$45 million.

During 2003 to 2006 Michael became the President and Co-Founder of MJS Holdings. He created an ASP for financial services and launched a wireless ISP in Ohio while acquiring two other wireless ISP's. During this time, he was involved with twelve acquisitions and divestitures in the technology space.

Bluemile ranked #445 on the 2011 *Inc.* 500, an exclusive ranking of the nation's fastest-growing private companies, making them the 16th fastest-growing company in its business space. Bluemile also ranked #4 in Columbus's *Columbus Business First Fast 50* companies in 2011.

In 2013, Denver-based WOW (Wide Open West) acquired Bluemile's cloud computing services and fiber-optic cable network. The acquisition added to WOW's cloud-based backup and disaster recovery services to business clients in 13 states and extended its network to New York City and Boston.

As part of his experience at Bluemile, Michael created public-private partnerships with local municipalities to maximize their potential in Fiber Optics. Through his experience, networks like New Albany Net, and Gahanna Net were created. These added revenue, jobs and opportunity to their communities. Michael intends to be paid directly by the suppliers, so the customer will not be billed directly.
