Lima Energy Company has filed an application with the Ohio Power Siting Board (OPSB) in the case of 14-1142-EL-BGA for an amendment to its certificate of environmental compatibility and public need issued for the construction and operation of its facility in Lima, Allen County, Ohio. The purpose of the amendment is to reconfigure the planned facility from an Integrated Gasification Combined Cycle facility, to an Ultra Clean Synthetic Crude (UCSC) production facility. Lima Energy Company does not believe that the changes proposed in this amendment will increase the impacts from the Facility. 
