Re: In the Matter of Notice of Compliance by Ohio Edison Company, The Cleveland Electric Illuminating Company and The Toledo Edison Company with the Electric Security Plan Case No. 14-1286-EL-ACP

Dear Sir or Madam:

Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively the "Companies") hereby provide notice that a Ten Year Request for Proposal for Renewable Energy Credits for the period of 2015 through 2024 will not be held in 2014 in accordance with the Stipulation in Case No. 12-1230-EL-SSO ("Stipulation").

Similar to the Second Supplemental Stipulation in Case No. 10-388-EL-SSO, the Stipulation provides: "[a]s the Companies have already held two (2) of the aforementioned RFPs, the Companies' application to the PUCO will provide for two additional years for the criteria to be met to potentially trigger the two (2) additional RFPs for ten year contracts for solar REC delivery beginning in 2015 and 2016."

The Stipulation also provides "If the standard service offer load of the Companies is less than 15,000,000 MWh [,] no additional solar RECs will be purchased that year." Further, the Stipulation states "the standard service offer load of the Companies for the purpose of the thresholds set forth above is calculated by multiplying the Companies' prior year non-shopping percentage, as submitted by the Companies to Commission Staff in December of each year, by the Companies' long term forecast as filed with the Commission on April 15 for the year in which an RFP may occur."

As demonstrated in the table below, the Companies' standard service offer load ("SSO Load") for the year in which the RFP may occur (2014) is less than 15,000,000 MWh based on the data provided in the Companies' long term forecast, which was filed on April 15, 2014 in case number 14-0625-EL-FOR, and the prior year non-shopping percentages.

Because the applicable SSO Load is less than the 15,000,000 MWh threshold set forth in the Stipulation, a Ten Year Request for Proposal for Renewable Energy Credits for the period of 2015 through 2024 will not be held in 2014.
