# SECOND APPLICATION OF THE DAYTON POWER AND LIGHT COMPANY TO UPDATE ITS RECONCILIATION RIDER NONBYPASSABLE AND REQUEST FOR EXPEDITED TREATMENT

The Dayton Power and Light Company ("DP&L" or "the Company") hereby submits this Second Application to update its Reconciliation Rider Nonbypassable ("RR-N") pursuant to the Finding and Order of the Public Utilities Commission of Ohio ("PUCO" or "Commission") dated May 28, 2014, in Case No. 14-0629-EL-RDR.

In support of this Application DP&L states as follows:

- 1. By Opinion and Order dated September 4, 2013, in Case

  Nos. 12-0426-EL-SSO, *et al.* ("ESP Opinion and Order"), the Commission approved an

  RR-N that should recover any deferred balance that exceeds 10 percent of the base

  amount of riders FUEL, RPM, AER, and CBT, as proposed by DP&L in its application.<sup>1</sup>
- 2. By Finding and Order dated May 28, 2014, in Case No. 14-0629-EL-RDR ("RR-N Finding and Order"), the Commission found that DP&L should file a separate application to include rider amounts above the 10 percent in the RR-N. <sup>2</sup> By way of this application, DP&L seeks to update its RR-N, which includes approved deferral balances

exceeding the 10 percent threshold of the base amount of riders FUEL and CBT, as authorized by the ESP Opinion and Order.

3. In support of this Application, the following Schedules are attached:

Schedule A Rate Development

Schedule B Deferral Balance Calculation

Workpapers

- 4. The updated RR-N rate for all kilowatt hours for the period September 1, 2014 through November 30, 2014, is \$0.0021981 per kWh.
- 5. The components in the RR-N rates for this filing include the deferral balances of riders FUEL and CBT that exceed 10% of the base amount in those riders consistent with the ESP Opinion and Order. DP&L is applying carrying charges of 4.943%, based on the cost of debt approved in the ESP Opinion and Order, to the total amount of the balances exceeding 10% of the base amount of each rider included in the RR-N. The RR-N will be trued-up on a seasonal quarterly basis.
- 6. DP&L's updated rates included in the RR-N, as reflected in Schedule A and as supported by the remaining Schedules and Workpapers, are just and reasonable and implementation should be approved expeditiously.
- 7. DP&L is seeking expedited treatment for this case so that rates will go into effect along with the other quarterly true-up riders, as approved by the ESP Opinion and Order, which would be in the public's interest.
- 8. Delay in approving this application will cause balances and customer bills to increase. The market structure in Ohio places DP&L in a situation in which it seeks to recover costs from customers that caused the costs to be incurred; however, those same

customers have the ability shop and avoid these costs which were incurred on their behalf. Ever increasing unrecovered balances are being assigned to an ever decreasing group of customers. This issue was already addressed by the Commission when it approved the use of this particular RR-N mechanism, in the ESP Opinion and Order. Therefore this case presents no new issues for the Commission's consideration – it is merely a request to update the rates of the approved RR-N with the most recent relevant deferral balances, and expedited treatment is just and reasonable.

WHEREFORE, DP&L respectfully requests that the Commission expeditiously approve its Second Application with updated tariff rates for its RR-N to be made effective on a bills-rendered basis with the Company's first billing unit beginning in September 2014.
