#### **Project Amendment Description**

The Applicant is proposing a minor adjustment to the East Springfield-London-Tangy 138 kilovolt (kV) Transmission Line, originally certificated under case number 11-4884-EL-BTX and amended under case number 13-2112-EL-BTA. Another amendment (ref: 14-0595-EL-BTA) is also pending before the Board.

This filing proposes to shift a 4,381-foot section of the approved alignment approximately 428 feet beyond the 1,000-foot study corridor for the certificated Preferred Route. The approved alignment segment is 4,381 feet in length, and the adjusted portion would be 5,497 feet long.

# **Amendment Review**

#### Social Impacts

Land use in proximity to the amendment is primarily comprised of industrial (active quarry mining), agricultural, and limited rural residential uses. The route adjustment has been filed to accommodate the requests of directly impacted property owners, as well as to alleviate the Applicant's engineering and operational concerns. The proposed route adjustment would allow the quarry to potentially expand their operations. Also, the Applicant's engineering concerns are greatly simplified by adoption of the amendment. Transmission structures that cross an active quarry would have to span large bodies of water, thus complicating future maintenance activities.

The Applicant has obtained verbal approvals for all needed easements and all directly affected property owners are party to those agreements. The Applicant is completing a cultural resource survey along the proposed adjustment. Results of that survey will be submitted to the State Historic Preservation Office, in accordance with the original certificate. This route adjustment would not significantly alter existing land use. No recreational or public parkland is crossed by this amendment. No residences will need to be removed in order to accommodate this proposal. This route adjustment is expected to result in an overall reduction of potential social impacts.

# Ecological Impacts

The Applicant has delineated water resources and searched for threatened and endangered (T&E) species. No T&E species were encountered by the Applicant, and potential adverse impacts to water resources would still be minimal.

# **Recommended Findings**

Staff recommends that the Board find that the proposed amendment to the certificate poses minimal social and environmental impacts.



Further, and 21 based on information from the property owners that has been shared with ATSI, it is also my 22 understanding that when the quarry ceases operation, the pit of the quarry will be allowed to 23 fill with water. Although transmission lines can be installed to cross water bodies, in general,

1	ATSI prefers not to locate transmission lines over open water as this creates additional
2	obstacles for future maintenance and repair of the transmission line. The proposed 3rd

THIRD AMENDMENT TO THE EAST SPRINGFIELD-LONDON-TANGY 138 kV TRANSMISSION LINE PROJECT

Case Number 14-0811-EL-BTA

On March 3, 2013 the Ohio Power Siting Board (Board) issued an Opinion, Order and Certificate, in Case Number 11-4884-EL-BTX, granting the Application of American Transmission Systems, Incorporated ("ATSI") ("Applicant") to construct a 138 kV electric transmission line along the proposed Preferred Route of the East Springfield-London-Tangy 138 kV Transmission Line Project ("Project"). On February 18, 2014, the Board approved seven adjustments to the Approved Route ("First Amendment"), in Case Number 13-2112-EL-BTA. The approved route incorporating the seven adjustments approved by the Board in the First Amendment is referred to in the following amendment application as the "Approved Route".

A second amendment ("Second Amendment") is pending before the Board in Case Number 14-0595-EL-BTA. The Second Amendment seeks a modification to Adjustment 3 in the First Amendment along the London-Tangy section of the Approved Route.

The attached "Third Amendment" to the East Springfield-London Tangy 138 kV Transmission Line Project proposes one additional adjustment to the Approved Route in Madison County along the London-Tangy section of the Approved Route. The proposed adjustment is described below:

**London-Tangy Section:** 

Adjustment 1: This adjustment modifies approximately 1.1 mile of the Approved Route, and is located to the northwest of a quarry between Plain City-Georgesville Road NE and East Main Street (State Highway 161) in Madison County near Plain City. The adjustment also crosses County Highway 242 and East Main Street near the northeastern end of the adjustment. This adjustment is requested by the Applicant and moves the OPSB Approved

Route approximately 0.2-mile to the west of the original Approved Route. This adjustment moves the route to a location that is adjacent to the western and northern edges of an existing quarry, and northeast of the quarry, moves the route location within agricultural fields. The property owners along the proposed adjustment have agreed to this proposed alignment. The property parcels included in the adjustment are:

3. The proposed location is located between Plain City-Georgesville Road NE and East Main Street (State Highway 161) in Madison County; Parcel Nos. 02-00355.000, 02-00316.001, and 04-00776.000.

The Applicant has reviewed this adjustment to the Approved Route and the adjustment can be made with no, or minimal, increases to Project impacts. The primary benefit of the Third Amendment it that it avoids the need to install new transmission line structures within the active quarry and allows for potential expansion of the quarry to the northeast. Additionally, it is the Applicant's understanding that when the quarry ceases operation, the pit will fill with water, and while transmission line structures can and are located above ponds and lakes, avoiding this type of installation will simplify future transmission line maintenance activities. Accordingly, the Applicant respectfully submits this request that the Approved Route be amended as described herein.

The Applicants describe the proposed amendment in the appendices that are attached. For the Board's convenience, and as the proposed adjustment falls within the criteria for a letter of notification application pursuant to the appendices to Ohio Administrative Code ("OAC") Rule 4906-1-01, the amendment information is presented in the Board's "Letter of Notification" ("LON") format. Specifically, Appendix A describes the change to the Approved Route, presented in the LON format. Appendix B lists the property owners and easements status per OAC Rule 4906-11-01(B)(7). Appendix C lists the current public officials, libraries and parties of record of the original certificate allocation proceedings being provided a copy of the Amendment per OAC Rule 4906-5-10(B)(2)(a).

# 4906-11-01 (B) (1) b: Brief Description of Project

This Amendment to the East Springfield-London-Tangy 138 kV Transmission Line Project proposes one modification to the London-Tangy section of the Project. The route approved by the Board (Case Nos. 11-4884-EL-BTX; 13-2112EL-BTA) is identified in the following as the "Approved Route". The modification is described below:

Adjustment 1. Between Plain City-Georgesville Road NE and East Main Street (State Highway 161) in Madison County; Parcel Nos. 02-00355.000, 02-00316.001, and 104-00776.000.

This adjustment modifies approximately 1.1 mile of the Approved Route, and is located to the northwest of a quarry between Plain City-Georgesville Road NE and East Main Street (State Highway 161) in Madison County near Plain City. This adjustment is located on properties with parcel number 02-00355.000 belonging to Claribel J. Yoder (Trustee, Yoder Family Trust), parcel number 02-00316.001

belonging to Tuffco Sand & Gravel, Inc., and parcel number 04-00776.000 belonging to Bethel Road Investment Co., Inc. This section of the Approved Route is located in Darby Township of Madison County, Ohio. Figure 04-1L Revision 2, Constraints Map for The London-Tangy Segment, provides the alignment of the proposed revised route in this area of the Project. Figure 07-7-W Revision 1, Preferred London-Tangy Segment Ecological Features map, provides an enlarged view of the Approved Route, and the proposed revised route in this area of the Project.

As shown in Figure 04-1L Revision 2, the proposed revised route begins approximately 190 feet east of where the Approved Route crosses Big Darby Creek. The adjusted route continues to the east for approximately 160 more feet before it turns to the north, and follows the northwestern edge of the quarry for approximately 0.3 mile. The adjusted route crosses a gravel road associated with the quarry, and continues to the northeast through an agricultural field for approximately 0.4 mile. The adjusted route then crosses County Highway 242 and continues through a mowed area for approximately 200 feet before it crosses East Main Street (State Highway 161) and turns approximately 90 degrees to the southeast. The adjusted route continues to the southeast through an agricultural field parallel to East Main Street for approximately 0.3 mile, and then rejoins the Approved Route.

A property owner, Claribel J. Yoder (Trustee, Yoder Family Trust) (parcel number 02-00355.000), along the section of the Approved Route that crosses through a quarry, has agreed to the proposed alignment of the adjusted route. The remaining property owners along the adjusted route, Tuffco Sand & Gravel, Inc. (parcel number 02-00316.001) and Bethel Road Investment Co., Inc. (parcel number 04-00776.000), have also agreed to this proposed alignment. This adjusted route moves the route to a location that is adjacent to the western and northern edges of an existing quarry, and northeast of the quarry, moves the route location within

agricultural fields. The Applicant believes the adjusted route does not significantly increase or decrease ecological impacts.

# 4906-11-01 (B) (1) c: Why the Project Meets the Requirements for a Letter of Notification

For the Boards convenience, and as the proposed adjustment falls under a letter of notification pursuant to the appendices to Ohio Administrative Code rule 4906-1-01, the amendment information is presented in the Board's "Letter of Notification" ("LON") format. This amendment filing falls under rule 4906-5-10(B) of the Ohio Administrative Code, which states: "Applications for amendments to certificates shall be submitted in the same manner as if they were applications for a certificate, unless such amendment falls under a letter of notification or construction notice pursuant to the appendices to rule 4906-1-01 of the Administrative Code." The Project meets the requirements for a Letter of Notification because the proposed adjustment is within the types of project defined by Item (1)(e) and (4)(a) of the Interim Application Requirement Matrix for Electric Power Transmission Lines in the Finding and Order issued on September 4, 2012 in Case No. 12-1981-GE-BRO, as modified and expanded by the Second Finding and Order issued in that case on December 17, 2012, both of which modified Appendix A of Rule 4906-1-01 of the Ohio Administrative Code. This item states:

- (1) Rerouting or extension or new construction of single or multiple circuit electric power transmission line(s) as follows:
  - (e) Line(s) one hundred twenty-five kV and above, but less than three hundred kV, and greater than 0.2 miles in length but not greater than two miles in length.

#### 4906-11-01 (B) (2): Need Statement

The need for the East Springfield-London-Tangy 138 kV Transmission Line Project was addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX) and can be found in Section 2 of the Application. The need for the Third Amendment is to accommodate the requests of property owners.

# 4906-11-01 (B) (3): Location Relative to Existing or Proposed Lines

The location of the Project relative to existing or proposed transmission lines is described in reference to the FirstEnergy System Facilities map, included as the last page of Chapter 3 of the confidential portion of the Ohio Edison Company, The Cleveland Electric Illuminating Company, The Toledo Edison Company and American Transmission Systems, Incorporated's 2013 Long-Term Forecast Report, submitted to the Public Utility Commission of Ohio (PUCO) in Case No. 13-0925-EL-FOR under Rule 4901:5-5-04(C) of the Ohio Administrative Code. This map shows ATSI's 345 kV and 138 kV existing transmission lines and transmission substations and does not depict the proposed location of the Project. In reference to the map, the proposed Project is located in Clark, Delaware, Madison, and Union Counties, approximately 5 inches (11 by 17 inch printed version) from the left edge of the map box and 7-1/2 inches (11 by 17 inch printed version) from the top of the map box.

#### 4906-11-01 (B) (4): Alternatives Considered

Consideration of the proposed adjustment was initiated to avoid installing new transmission line structures within the active area of the quarry and allows for the potential expansion of the quarry to the northeast. Additionally, it is the Applicant's understanding that at the end of the quarry activities, the quarry will be allowed to fill with water, and although transmission line structures can and do cross ponds and lakes, avoiding this type of installation will simplify future transmission line maintenance activities. At the proposed relocation area, the potential area was carefully reviewed to identify potential ecological and social impacts associated with various potential alignments as well as to accommodate the property owners'

wishes. The Applicant believes the proposed adjusted route represents the best solution for installing the transmission line in consideration of the existing quarry operations and following discussions with the property owners' while carefully avoiding other impacts. In the event that the proposed adjustment is not approved by the Board, the Applicants intend to proceed with constructing that portion of the project on Approved Route.

4906-11-01 (B) (5): Construction Schedule

The Applicants are currently constructing portion of the London-Tangy section of the Project, except for the areas included in this amendment. Construction in the area of the proposed adjusted route is expected to commence shortly after the Board approval.

4906-11-01 (B) (6): Area Map

A map of the overall project location was addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX) and can be found in Figure 04-1A through Figure 04-1M. The location of the proposed adjustment to the Approved Route is provided in Figure 041-1L Revision 2 and Figure 07-7-W Revision 1.

4906-11-01 (B) (7): Property Owner List

The status of easements, options, and/or land use agreements necessary to construct the change and operate the facility is listed in Appendix B, which accompanies the Third Amendment.

4906-11-01 (C): Technical Features

4906-11-01 (C) (1): Operating Characteristics

The proposed revised adjustment of the Approved Route will not change the operating characteristics that were addressed and considered in the previous

application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX), found on pages 04-13 through 04-16.

# 4906-11-01 (C) (2) a: Calculated Electric and Magnetic Fields

The change to the Approved Route will not materially change the electro-magnetic field (EMF) calculations that were addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX), on pages 06-45 through 06-48.

# 4906-11-01 (C) (3): Estimated Costs

The change to the Approved Route will not significantly affect the estimated capital costs by FERC Accounts for the Project that were addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX), found on page 05-5 and Table 05-1.

#### 4906-11-01 (D): Socioeconomic Data

#### 4906-11-01 (D) (1): Land Use

The change to the Approved Route crosses land use that was addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX), found on pages 06-14 through 06-24. No changes to land use are anticipated as a result from the shift from the Approved Route to the adjusted route.

#### 4906-11-01 (D) (2): Agricultural Land

The adjustments to the Approved Route cross similar percentage of land use that was addressed and considered in the previous application filing and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX), found on page 06-20.

The adjusted route will pass through mowed fields and agricultural fields similar to the Approved Route on the various properties crossed by the Project.

### 4906-11-01 (D) (3): Archaeological or Cultural Resources

In accordance with the OPSB Opinion, Order and Certificate, an investigation and report of cultural resources has been prepared for the balance of the East Springfield-London-Tangy 138 kV Transmission line Project. The Phase 1 cultural resource survey for Adjustment 3 has not been completed, but will begin in the near future. The results of the field evaluation will be submitted as an addendum report to the OHPO and OPSB likely in June 2014.

### 4906-11-01 (D) (4) a: Documentation of Letter of Notification Transmittal

The Third Amendment is being provided concurrently to the current public officials, libraries and parties of record as listed in Appendix C, which accompanies the Amendment.

### 4906-11-01 (D) (4) b: Public Information Program

ATSI's Manager of External Affairs will advise local officials of features and the status of this Third Amendment, as necessary.

#### 4906-11-01 (D) (5): Current or Pending Litigation

This amendment is being submitted to resolve pending litigation regarding the Approved Route in relation to the parcels described in this filing.

### 4906-11-01 (D) (6): Local, State, and Federal Requirements

There are no known local, state, or federal requirements that must be met prior to commencement of construction of the change to the Approved Route.

#### <u>4906-11-01 (E): Environmental Data</u>

#### 4906-11-01 (E) (1): Endangered, Threatened, and Rare Species Investigation

An investigation of endangered or threatened species was addressed and considered in the previous supplement application filing in July 2011 and the subsequent OPSB Opinion, Order and Certificate of the original Application (11-4884-EL-BTX).

#### 4906-11-01 (E) (2): Areas of Ecological Concern

An assessment of areas of ecological concern is provided below for the proposed adjustment to the Approved Route:


Adjustment 1. Between Plain City-Georgesville Road NE and East Main Street (State Highway 161) in Madison County; Parcel Nos. 02-00355.000, 02-00316.001, and 104-00776.000.


A wetland delineation and stream assessment of the adjustment area was performed on May 5, 2014. This proposed adjustment crosses a small portion (approximately 11 linear feet) of a palustrine open water/emergent wetland located on the northeastern edge of the quarry property (Wetland 28). Wetland 28 is highly-disturbed and receives water from quarry dewatering pumps. The proposed adjustment also lies within approximately 60 feet of an intermittent stream (Stream 27, Tributary to Big Darby Creek), but it is not proposed to cross this stream.

The Applicants have carefully located the centerline of this proposed adjustment to avoid the majority of Wetland 28, and no poles are proposed to be located within the wetland. The Applicants believe that the construction, operation, and maintenance of the transmission line along the proposed adjustment will have no significant impact to ecological features.

#### 4906-11-01 (E) (3): Additional Information

Construction and operation of the proposed Project will be in accordance with the requirements specified in the latest revision of the NESC as adopted by the PUCO and will meet all applicable safety standards established by OSHA.
