Construction Notice for PIR #264, Sugar Street, Lima, Allen County, Ohio 12-inch High Pressure Distribution Line Replacement, OPSB Case No. 14-1327-GA-BNR

Dear Mr. Donlon and Ms. McNeal:

Dominion East Ohio ("DEO") is planning to replace replacing approximately 5,369 feet of existing 6- and 10-inch high-pressure bare steel with 695 feet of 6-inch fusion bond epoxy steel .280W by grade B and 5,075 feet of 12-inch fusion bond epoxy steel .375W by grade X-42. The contractor will install one 6-inch ball valve and four 12-inch valves. This construction project will run on the west side of Sugar Street in the tree lawn between Kibby Street and 4th Street in the City of Lima, Ohio.

The replacement pipeline will be located entirely within DEO's service area. The primary purpose of the replacement will be to take out of service the aging and obsolete pipeline to assure a safe and constant natural gas supply to DEO's customers. This project is eligible for recovery as part of the Pipeline Infrastructure Replacement program. The construction of the replacement pipeline is anticipated to begin in September 2014. DEO plans to place the line in-service by December 15, 2014.

DEO submitted payment of \$2,000 in accordance with Ohio Administrative Code Rule 4906-5-11(I) so that the Construction Notice will be considered on an expedited basis. If you have any questions please call at the number listed above.
