Dear Ms. McNeal:

On March 17, 2014, the Ohio Power Siting Board ("Board") issued a Certificate of Environmental Compatibility and Public Need subject to a number of conditions.

Condition No. 17 of the Board's Order requires the following:

**Vectren shall have a Staff-approved environmental specialist on site during construction activities that may affect sensitive areas, as mutually agreed upon between the Applicant and Staff, and as shown on the Applicant's final approved construction plan. Sensitive areas include, but are not limited to, areas of vegetation clearing, designated wetlands and streams, and locations of threatened or endangered species or their identified habitat. The environmental specialist shall be familiar with water quality protection issues and potential threatened or endangered species of plants and animals that may be encountered during project construction.**

In compliance with Condition No. 17 of the Board's Opinion, Order, and Certificate, attached for filing is a memo dated September 2, 2014, from Ms. Stahl to the Board's Staff regarding the removal of the temporary stream crossings for stream #3 and 4.

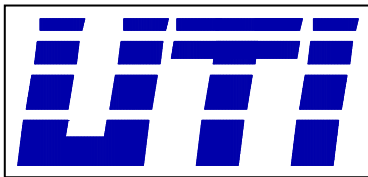
