MEMORANDUM IN SUPPORT

This is a consolidation project which involves the installation of premium surfaces at two of the City of Middletown's grade crossings (Central Avenue and Verity Parkway, DOT#s 524-677N and 525-342C, respectively) to be followed by the consolidation/closure of the City's Grand Avenue grade crossing (524-680W).

Substantial progress has been made – specifically, the premium surfaces have been installed at both Central and Verity Parkway. The involved parties (the City, the ORDC, and Norfolk Southern) remain in the process of trouble-shooting various concerns re the surface installations, and which may necessitate additional construction at the respective crossings; accordingly, and with winter weather approaching (including the closing of asphalt plants, etc.), Norfolk Southern respectfully requests an extension of time of six (6) months – through March 18, 2015 – within which to complete this consolidation project.

The City has been advised of and consents to this request.
