MEMORANDUM IN SUPPORT

The RFP approved by this Commission's April 15, 2014 order requires the audit report to be submitted by August 29, 2014. By an August 27, 2014 Attorney Examiner order, the due date was changed to September 15, 2014 granting a Staff motion. Just as the preparation of the audit itself required more time than had been anticipated, the compilation of the audit results into a report has proven to be more challenging than had been anticipated. The situation necessitates an additional three weeks, until October 6, 2014. Postponing the due date will allow sufficient time for the auditor to compile a thorough report and will provide the Commission with the information needed to adequately review the subject matter of the case. Therefore the Staff asks that the due date be moved to October 6, 2014. We do not believe that moving these dates will prejudice any party and should allow a complete development of the issues. The parties to the case on the service list have been contacted and have no objection to the extension.
