(1) Name of the Project

The name of the project is Hazelton 138kV Transmission Line Tap Project.

(2) Description of this Project

The proposed project consists of constructing a 138kV tap line in and out off of the Kirk-Jug 345kV/138kV transmission line to service the proposed Hazelton distribution station operated by The Energy Cooperative (TEC) on the south side of Hollow Road in Pataskala, Licking County, Ohio. The project extends for approximately 800 feet.

(3) Need for this Project

The project is needed to service the proposed distribution substation and provide additional electrical capacity in the Pataskala and Licking County area.

(4) Construction Schedule

Construction is scheduled to begin early November 2014 with an estimated completion date of December 12, 2014.


