2 appearing at the hearing. However, we have  
3 given a little additional time this morning  
4 beyond 10:00 o'clock. It's now 10:15, and Mr.

6 Mr. Lindgren, would you like to  
7 continue, please.

8 MR. LINDGREN: Yes, I would, your  
9 Honor. At this time I would like to move for a  
10 default judgement under the Commission's rules  
11 given that the Respondent has not appeared at  
12 the hearing.

13 ATTORNEY EXAMINER: All right.  
14 Thank you. We will take that into  
15 consideration. And do you have any exhibits you  
16 want to introduce into the record?

17 MR. LINDGREN: Yes, Your Honor. I  
18 would like to introduce as Exhibits 1 and 2 the  
19 inspection report and the Notice of Preliminary  
20 Determination in case No. 14-269-TR-CVF.

24 Then I would also like to introduce  
25 as Exhibits 3 and 4 the inspection report and

1 the Notice of Preliminary Determination for Case  
2 No. 14-1089-TR-CVF.

3 I have marked as Exhibit 3 the  
4 inspection report, and I have marked as Exhibit  
5 4 the Notice of Preliminary Determination.

6 ATTORNEY EXAMINER: Thank you.

7 MR. LINDGREN: I would move for the  
8 admission of these exhibits. And with that I  
9 rest my case.

10 ATTORNEY EXAMINER: Thank you, Mr.  
11 Lindgren. We will admit Exhibits 1, 2, 3 and 4  
12 into the record.
