Dear Resident or Property Owner,

The first local public hearing, pursuant to Section 4906.08(C), of the Ohio Revised Code ("ORC") for the proposed Biers Run-Circleville 138-kV Transmission Line Project will be held on Wednesday, November 5, 2014, at 6:00pm, at the Pioneer School of Developmental Disabilities, 11268 County Road 550, Chillicothe, Ohio, 45601. A second public hearing, for this project will be held on Thursday, November 6, 2014, at 6:00 pm, at the Amvets Post 2256, 818 Tarlton Road, Circleville, Ohio 43113. At these local public hearings, the Ohio Power Siting Board ("OPSB") shall accept written or oral testimony from any person. AEP Ohio Transmission Company ("AEP Ohio Transco") invites all residents and property owners who wish to present written or oral testimony, to attend these public hearings.

An adjudicatory hearing will commence on Friday, November 14, 2014, at 10:00am 11th floor, Hearing Room 11-D, at the offices of the Public Utilities Commission of Ohio, 180 East Broad Street, Columbus, Ohio 43215-3793. This hearing is open to the public, but participation is limited to parties in the case as defined by ORC §4906.08.

AEP Ohio Transco has filed an application for a "Certificate of Environmental Compatibility and Public Need" for this project with the OPSB. This application has been assigned Case Number 13-0430-EL-BTX. Section 4906.07 of the ORC provides that: upon the receipt of an application, complying with Section 4906.06 of the ORC, the power siting board shall promptly fix a date for a public hearing thereon not less than 60 or more than 90 days after such receipt and shall conclude the proceeding as expeditiously as practicable. Pursuant to this rule and as previously stated within this letter, this hearing has been scheduled.

AEP Ohio Transco has published a notice in Pickaway and Ross counties area newspapers, the *Circleville Herald* and the *Chillicothe Gazette*, announcing a local public hearing for a proposed major utility facility. The notice provides the time, date and place of the local public hearing, as well as, information about AEP Ohio Transco's plans to construct a new high voltage transmission line in the Circleville and Chillicothe area in Pickaway and Ross counties, respectively.

In addition to the notice of a local public hearing – this was published in the *Circleville Herald* and the *Chillicothe Gazette* – we are sending this letter to each property owner and affected tenant within the immediate area of the proposed transmission line as required by Ohio Administrative Code ("OAC") Rule 4906-5-08(C)(3). A second public notice or reminder newspaper advertisement notice will be published in the same newspaper in October 2014 according to OAC Rule 4906-5-08(C)(2).

The Biers Run-Circleville Transmission Line Project will extend from the Biers Run Substation to the Circleville Substation. The Biers Run-Circleville Line will be approximately 19 miles long depending on the route selected, and will be located in Pickaway and Ross counties. The Line will likely run through

Circleville, Deer Creek, Jackson and Wayne townships in Pickaway County and Deerfield and Union townships in Ross County.

The Biers Run-Circleville 138-kV Transmission Line Project is part of the overall Biers Run Project. The Biers Run Project is a major transmission reinforcement effort to help AEP Ohio maintain transmission reliability in south central Ohio. The total project will allow the company to address reliability concerns, potential low voltages and potential thermal overloads.

Three 138-kV transmission lines provide electric service to the Chillicothe and Circleville areas. Simultaneous outages on any two of these lines could affect electric supply throughout the area. Further, electric demand in Ross, Pickaway and surrounding counties is straining the existing transmission infrastructure. In addition to strengthening the grid, this Project will support future growth in the region.

Copies of the actual siting application, including specific details about the location and construction, are available for public inspection at the following locations: Pickaway County District Library, Chillicothe and Ross County Public Library and the Ohio Power Siting Board - Public Utilities Commission of Ohio. An electronic version of the siting application can be found at the Ohio Power Siting Board website at <http://opsb.ohio.gov>. Search under current cases for Case Number 13-0430-EL-BTX.

The following local city and county government officials in Pickaway County have been served with a copy of the application as required by the OPSB regulations: Pickaway County Commissioners, Pickaway County Engineer, Pickaway County Office of Development and Planning, Pickaway County Department of Public Services and Planning, Circleville Township Trustees, Deer Creek Township Trustees, Jackson Township Trustees, Wayne Township Trustees, Circleville City Council and City of Circleville Mayor. The following local city and county government officials in Ross County have been served with a copy of the application as required by the OPSB regulations: Ross County Commissioners, Ross County Engineer, Ross County Planning Department, Deerfield Township Trustees and Union Township Trustees. The state power siting board has served the following state agencies with copies of the application: Public Utilities Commission of Ohio, Ohio Department of Agriculture, Ohio Department of Development, Ohio Department of Health, Ohio Department of Natural Resources, Ohio Department of Transportation, Ohio Environmental Protection Agency and the Ohio Historical Society.

In conclusion and to reiterate, two local public hearings will be held on Wednesday, November 5, 2014, at 6:00pm, at the Pioneer School of Developmental Disabilities, 11268 County Road 550, Chillicothe, Ohio, 45601, and Thursday, November 6, 2014, at 6:00 pm, at the Amvets Post 2256, 818 Tarlton Road, Circleville, Ohio 43113, where the OPSB shall accept written or oral testimony from any person. The OPSB will consider comments from the public and the OPSB Staff Report when evaluating the application.
