On October 6, 2014, Indianapolis Power & Light Company received your inquiry regarding the August 18, 2014, IND Solar Farm (1st Phase) Application for Certification as an Eligible Ohio Renewable Energy Resource Generating Facility and respectfully submits the following responses:

Question 1: Under Question D of the application, the organization is listed as "General Energy

Solutions USA, Inc." – this appears inconsistent with information provided in response to Questions B and E. Please confirm if accurate, or revise if necessary.

Answer 1: The correct name of the organization under "D. Name of Generation Facility Operating Company" is consistent with Questions B and E; "ET Energy Solutions, LLC".

- **Question 2:** The facility's capacity is listed as 10 MW AC please confirm that the capacity is 12.6 MW DC.
- **Answer 2:** Yes; the facility's nameplate capacity is 12.6 MW DC and 10 MW AC.
- Question 3: With respect to the applicant's intentions to register the facility with M-RETS, has the registration been completed or is it still currently pending?
- Answer 3: The M-RETS registration was completed August 14, 2014, and is pending approval of the meter reporting process between IPL and M-RETS. IPL anticipates this will be finalized next week.
- **Question 4:** Does the PPA under Rate REP with IP&L include the S-RECs associated with this facility, or are the S-RECs retained by another entity?
- **Answer 4:** Indianapolis Power & Light Company ("IPL") is the owner of the sRECs under the terms of the PPA with ET Energy Solutions, LLC, the facility owner.

Responses within 10 business days will help ensure that the application does not have to be suspended.

1. Under Question D of the application, the organization is listed as "General Energy Solutions USA, Inc." – this appears inconsistent with information provided in response to Questions B and E. Please confirm if accurate, or revise if necessary.

<Jack> Yes, it should be consistent with Questions B and E. The correct Organization should be ET Energy Solutions, LLC. Both ET and GES are located at the same address and in fact, GES own 100% share of ET.

- The facility's capacity is listed as 10 MW AC please confirm that the capacity is 12.6 MW DC. <Jack> It is 10MWac and 12.57MWdc
- 3. With respect to the applicant's intentions to register the facility with M-RETS, has the registration been completed or is it still currently pending?

<Jack> According to IPL, the M-RETS registration has been completed and is pending approval; IPL anticipates this being approved by sometime next week (week of 10/13). This is something IPL registered on August 14th.

4. Does the PPA under Rate REP with IP&L include the S-RECs associated with this facility, or are the S-RECs retained by another entity?

<Jack> SRECs belong to IP&L as indicated in PPA with them.
