MEMORANDUM IN SUPPORT

Diversegy, LLC ("Diversegy") hereby requests a thirty (30) day extension of its Certificate No.12-605E(1), pursuant to Admin. Code 4901:1-24-09(A). Diversegy's certificate became effective on November 30, 2012 and expires on November 30, 2014.

Rule 4901:1-24-09(A) provides in pertinent part:

If the provider files such renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty calendar days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion.

Under Admin. Code 4901:1-24-09(A), Diversegy's Renewal Application was due to be filed no less than thirty (30) days prior to the expiration date indicated on its CRES provider certificate, or October 31, 2014. Diversegy has not yet filed its Renewal Application and requests the additional time in order to complete the preparation of its Renewal Application and supporting exhibits.

For the all of the foregoing reasons, Diversegy, LLC respectfully requests that its Certificate No. 12-605E(1) be automatically extended for thirty (30) days as permitted in Rule 4901:1-24-09(A).
