## MEMORANDUM IN SUPPORT

On November 16, 2012, in the above-captioned matter, the Commission issued Certificate Number 12-591E(1), which certified NPS as a competitive retail electric service aggregator/power broker. By its terms, the certificate expires on November 15, 2014. Unfortunately, due to an oversight, a renewal application to extend the effectiveness of the certificate was not filed thirty days prior the date of expiration of the certificate. NPS did, however, file a renewal application in this docket on October 30, 2014.

Due to concerns regarding certification as a competitive retail electric service aggregator/power broker during the short window of time in which the original application ceases to be effective and the Commission may still be reviewing NPS's renewal application, NPS files this motion to extend the effective date of Certificate Number 12-591E(1). NPS requests that the Commission extend the effective date of the certificate to encompass the period of its review of NPS's renewal application which may not be covered under the terms of the original certificate, such that, if its renewal application is approved, there will be no break in NPS's certification.

For these reasons, NPS respectfully requests that the Commission grant its motion to extend its certification during the period in question.
