## MOTION FOR PREHEARING CONFERENCE

A pre-hearing conference will allow all interested parties to mutually agree on a time and date on which to hold the hearing on the Petition to Close to Vehicular Traffic the Bloomingrove-New Winchester Road (Crawford-Morrow County Line Road) Grade Crossing. Additionally, CSXT has completed most, if not all, necessary discovery.. Among those deposed were the County Sheriffs, Fire Chiefs, EMS personnel, and school transportation personnel. CSXT respectfully requests a ruling as to whether it may read pertinent portions of this sworn testimony into evidence in lieu of live testimony so as to avoid unnecessary inconvenience to the witnesses, all of whom work and/or reside in Crawford and Morrow Counties.

Wherefore, CSXT respectfully requests that the Attorney Examiner schedule a prehearing conference to resolve any remaining discovery issues, identify witnesses and exhibits to be presented in the proceeding, to discuss the admissibility of deposition transcripts in lieu of live testimony, and to clarify and/or resolve any other issues involved

in the proceeding in advance of the hearing on the subject Petition. With regard to scheduling, because of the upcoming Thanksgiving Holiday, as well as the Holidays in the second half of December, CSXT respectfully suggests that a pre-hearing conference be scheduled for the month of December, and the Hearing for the week of January 19.1
