Mr. and Mrs. Greene,

Your comments concerning American Electric Power Transmission Company's (AEP Transco) proposed Gable Substation were forwarded to the Ohio Power Siting Board (OPSB).

Your correspondence in regards to the Gable Substation project has been docketed in case number 14-1280-EL-BSB. It is noted that you are in support of the "Red Site" of the substation, as proposed by AEP Transco at their September 23, 2014 public informational meeting. In the Application in this matter to the OPSB, this "Red Site" is known as the Alternate Site.

The OPSB Staff is currently reviewing the Application to determine that AEP Transco has submitted a detailed proposal for the project, including information on the probable impact of the proposed facility.

Once an Application is deemed to be complete, the OPSB Staff investigates each project and summarizes its recommendation to the Board in a Staff Report of Investigation, which is made available to the public through the OPSB website. Several criteria are considered, including potential environmental and ecological impacts, public interests, and the impact on agricultural land, among others. The Staff Report of Investigation serves as a recommendation to the Board, which ultimately whether or not to certificate the project.

A local public hearing will be held in the case at a date scheduled by the Administrative Law Judge. Information about this hearing will be published by the Applicant and available on the OPSB website at www.opsb.ohio.gov.
