Dear Chairman Johnson:

I write to you today as the head of the Zanesville-Muskingum County Port Authority, the lead economic development organization in Muskingum County in support of AEP Ohio's Power Purchase Agreement (PPA) proposal (Case No. 14-1693-EL-RDR and Case No. 14-1694-EL-AAM). It is my understanding that when combined with AEP's electric service plan, the proposed PPA should result in lower electric rates for consumers and businesses, but this savings is a secondary consideration.

I support the PPA proposal because the statutory deregulation of electric generation appears to have missed the mark and created a new set of challenges. The promised cost savings have certainly not materialized in our region, and energy-intensive industries, which are economic engines, have been penalized. More troubling, our electricity is becoming more vulnerable to disruption and market swings.

Returning some stability through the PPA to the electric market will benefit the regional economy and guard against the unpredictability that could cause needed base-load power to be unavailable in the future. It is my understanding that utilities in Ohio have recently announced the closure of 5,500 megawatts of generating capacity in Ohio. Our state will become an electricity importer. While much of the retirements are because of EPA regulations, market fluctuations could cause even more shut downs.

It seems nonsensical to me that environmentally compliant, low-cost generating units like 4, 5 & 6 at the Conesville plant could be shut down when market volatility or another Polar Vortex could put the cost and reliability of our electricity at risk. Pure market forces do a lousy job of long-term planning and protecting citizens. I ask that the PUCO do what it can to bring sensible regulation wherever it can back to the electric market.
