**MOTION TO APPEAR PRO HAC VICE
OF DERRICK PRICE WILLIAMSON**

Pursuant to Ohio Administrative Code § 4901-1-08(B) and the Supreme Court of Ohio Government of the Bar Rule XII(2)(A)(6), Lisa M. Hawrot, an attorney licensed to practice in the State of Ohio, respectfully moves the Public Utilities Commission of Ohio to permit Derrick Price Williamson to practice *pro hac vice* in the above-captioned proceedings on behalf of Wal-Mart Stores East, LP, and Sam's East, Inc. In support of this Motion, Movant represents that:



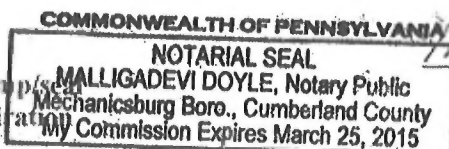
