- (2) An evidentiary hearing in these proceedings commenced on June 3, 2014, and concluded on June 30, 2014. Briefs and reply briefs were filed on July 23, 2014, and August 15, 2014, respectively.
- (3) By Entry issued on December 3, 2014, the Commission scheduled an oral argument for December 17, 2014.
- (4) Gov.Bar R. XII(2)(A) provides rules governing eligibility to practice pro hac vice in Ohio. Pursuant to Gov.Bar R. XII(2)(A)(6), motions for admission pro hac vice must be accompanied by a certificate of pro hac vice registration furnished by the Supreme Court Office of Attorney Services.
- (5) On December 5, 2014, a motion to appear pro hac vice and certificate of pro hac registration were filed by Madeline Fleisher on behalf of Environmental Law & Policy Center. The attorney examiner finds that the motion is reasonable and should be granted on an expedited basis pursuant to Ohio Adm.Code 4901-1-12(F).

ORDERED, That the motion to appear pro hac vice filed on December 5, 2014, by Madeline Fleisher be granted. It is, further,
