**Re: Letter of Notification of Compliance for a Second Stage of  
Construction by Trishe Wind Ohio, LLC,  
Case No. 13-197-EL-BGN**

Dear Ms. McNeal:

The December 16, 2013 Opinion, Order, and Certificate approving Northwest Ohio Wind Energy, LLC's [now known as Trishe Wind Ohio, LLC ("Trishe")] Certificate of Environmental Compatibility and Public Need ("Certificate") and the October 1, 2013 Supplement to Amended Application ("Supplement") established a set of conditions and supplemental commitments as part of the Certificate.

Within this set of conditions and commitments, **"Supplement Commitment No. 6"** requires that:

**For both construction and future right-of-way maintenance, Applicant will limit, to the greatest extent possible, the use of herbicides in proximity to surface waters, including wetlands along the right-of-way. Individual treatment of tall-growing woody plant species is preferred, while general, widespread use of herbicides during initial clearing or future right-of-way maintenance would only be used where no other options exist, and with prior approval from the Ohio EPA. Prior to commencement of construction, Applicant will submit a plan to OPSB Staff for review and acceptance, describing the planned herbicide use for all areas in or near any surface waters during initial [Second Construction] construction and/or future right-of-way maintenance.**

There is no herbicide application planned during the construction of the selected access roads and initial foundation work. This letter is to inform the OPSB Staff that Trishe is in compliance with the above-mentioned commitment.
