
MEMORANDUM IN SUPPORT

On December 12, 2012 in Case No 12-3042, the PUCO issued Certificate Number 12-615(E)(1), which certified EMS as a competitive retail electric service aggregator/power broker. By its terms the certificate expires December 21, 2014. Unfortunately, due to an inadvertent oversight due to personnel changes since the initial application was filed, a renewal application to extend the effectiveness of the certificate was not timely filed. Upon realization of this unfortunate oversight, EMS has submitted a hard copy of its renewal application, which should arrive at the PUCO via the U.S. Postal Service on December 15, 2014, before the end of the current certificates expiration date.

However, due to concerns certification as a competitive retail electric aggregator/power broker during the period of time in which the PUCO will review the renewal application, EMS files this motion to extend the effective date of Certificate Number 12-615(E)(1). EMS requests that the Commission extend the effective date of the certificate to encompass the entirety of its review of EMS's new application, such that, if the new application is approved, there will be no break in EMS's certification.

For these reasons, EMS respectfully requests that the PUCO grant its motion to extend effectiveness during the period in question.
