ENTRY

The attorney examiner finds:

- (1) On December 20, 2013, Ohio Power Company d/b/a AEP Ohio (AEP Ohio) filed an application for a standard service offer pursuant to R.C. 4928.141. The application is for an electric security plan in accordance with R.C. 4928.143.
- (2) An evidentiary hearing in these proceedings commenced on June 3, 2014, and concluded on June 30, 2014. Briefs and reply briefs were filed on July 23, 2014, and August 15, 2014, respectively.
- (3) By Entry issued on December 3, 2014, the Commission scheduled an oral argument for December 17, 2014.
- (4) Gov.Bar R. XII(2)(A) provides rules governing eligibility to practice pro hac vice in Ohio. Pursuant to Gov.Bar R. XII(2)(A)(6), motions for admission pro hac vice must be accompanied by a certificate of pro hac vice registration furnished by the Supreme Court Office of Attorney Services.
- (5) On December 12, 2014, a motion to appear pro hac vice and certificate of pro hac vice registration were filed by Jacob Bouknight on behalf of AEP Ohio. The attorney examiner finds that the motion is reasonable and should be granted on an expedited basis pursuant to Ohio Adm.Code 4901-1-12(F).

It is, therefore,

ORDERED, That the motion to appear pro hac vice filed on December 12, 2014, by Jacob Bouknight be granted. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
