ENTRY

The attorney examiner finds:

- (1) On November 11, 2014, Diversegy, LLC, (Diversegy or Company) filed a motion for extension of its certificate, No. 12-279G(1), requesting an extension until December 30, 2014.
- (2) By Entry dated November 19, 2014, Diversegy's motion was granted, and the Company's certificate was extended as requested, until December 30, 2014. Accordingly, at that time, Diversegy had until November 30, 2014, to file its renewal application.
- (3) On December 10, 2014, Diversegy filed its renewal application; thus, providing the Commission with less than 30 days to review the application.
- (4) On December 11, 2014, Diversegy filed a motion for a second extension of Certificate No. 12-279G(1). In the memorandum in support of the motion, Diversegy notes that its renewal application was not filed with an accompanying motion for extension. Diversegy, accordingly, requests a second extension of Certificate No. 12-279G(1) until January 10, 2015. Diversegy states that this extension will provide the Commission with the requisite 30 days in which to review its renewal application.
- (5) The examiner believes that a second extension of the expiration date of Certificate No. 12-279G(1) is warranted. The examiner also finds that an extension of that expiration date until January 10, 2015, would allow the Commission adequate time for review of the application.
- (6) As noted in the November 19, 2014 Entry granting Diversegy's first motion for an extension of its certificate, the examiner would reiterate that filing an application for renewal on a

timely basis is important. Subsequent renewal filings should be made in compliance with the governing rule.

It is, therefore,

ORDERED, That the motion for a second extension of Diversegy's certificate expiration date be granted. It is, further,

ORDERED, That the December 30, 2014 expiration date of Certificate No. 12-279G(1) be extended to January 10, 2015. It is, further,

ORDERED, That Diversegy comply with finding (6). It is, further,

ORDERED, That a copy of this Entry be served upon each party of record.
