**MOTION TO APPEAR PRO HAC VICE  
OF CARRIE M. HARRIS**

Pursuant to Ohio Administrative Code § 4901-1-08(B) and the Supreme Court of Ohio Government of the Bar Rule XII(2)(A)(6), Lisa M. Hawrot, an attorney licensed to practice in the State of Ohio, respectfully moves the Public Utilities Commission of Ohio to permit Carrie M. 

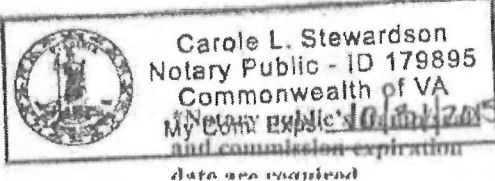
