

Our electric bill is remitted to the City of Hudson, but the issue related to locking consumers into buying power from FirstEnergy for an extended period of time is important to all residents. There are three specific issues about which I am concerned:

First, citizens of Ohio are painfully aware of the age of our coal plants and subsequently their inefficiency and exceptionally high rate of emission of pollutants. Anyone aware of the critical crisis we face regarding quality of air and the impact of old coal burning plants on the environment and on climate change must realize that this situation must be addressed without delay by the providers themselves.






