ENTRY

The attorney examiner finds:

- (1) Ohio Power Company d/b/a AEP Ohio (AEP Ohio or the Company) is a public utility as defined in R.C. 4905.02 and an electric utility as defined in R.C. 4928.01(A)(11), and, as such, is subject to the jurisdiction of this Commission.
- (2) By Entry issued on January 9, 2015, in the above listed cases, a procedural schedule was established. The January 9, 2015 Entry, established a date for the prehearing conference, January 27, 2015; the commencement of the evidentiary hearing, February 23, 2015; and the due date for the filing of testimony, February 6, 2015.
- (3) The scheduled hearing date in this matter coincides with the hearing scheduled in *In re Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company for Authority to Provide for a Standard Service Offer Pursuant to R.C. 4928.143 in the Form of An Electric Security*

Plan. To better facilitate the participation of interested parties in both proceedings, the procedural schedule in this case should be revised. Accordingly, the prehearing conference, the due date for the filing of testimony, and the commencement of the hearing in AEP Ohio's fuel adjustment clause proceedings will be rescheduled by entry to be issued in the near future. The intervention deadline, however, remains January 16, 2015.

It is, therefore,

ORDERED, That the procedural schedule, except for the intervention deadline, is suspended, until further notice. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
