**ERRATA FOR STIPULATION AND RECOMMENDATION FILED ON DECEMBER 22,
2014 BY OHIO EDISON COMPANY, THE CLEVELAND ELECTRIC ILLUMINATING
COMPANY, AND THE TOLEDO EDISON COMPANY**

Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company (collectively, “the Companies”), pursuant to the Entry issued on January 14, 2015, file the following errata revision to the Stipulation and Recommendation filed on December 22, 2014 (“the Stipulation”).

Paragraph V.B.7 on page 13 of the Stipulation as filed on December 22, 2014 reads:

EE/PDR Amended Plan. The energy efficiency and peak demand reduction programs recommended above by the Stipulated Parties will be additions to the Companies’ Amended Plan approved by the Commission in Case No. 12-2190- EL-POR, et al. Approval of the Stipulation by the Commission constitutes the Commission’s approval of these programs for inclusion in the Amended Plan pursuant to paragraph 5 of the Verified Application in Case No. 12-2190-EL-POR, et al. The Commission's approval is a necessary action to administer the implementation of the Amended Plan as provided in paragraph 5 of the Verified Application.

The above language should be deleted and should be replaced with the following language:

EE/PDR Amended Plan. The energy efficiency and peak demand reduction programs recommended above by the Stipulated Parties may be additions to the Companies’ Amended Plan approved by the Commission in Case No. 12-2190-EL-POR, et al. If the Commission deems it necessary to administer the

implementation of the Companies' Amended Plan, such approval shall constitute the Commission's approval of these programs for inclusion in the Amended Plan pursuant to paragraph 5 of the Verified Application in Case No. 12-2190-EL-POR, et al.
