



Where is the commitment to the future? Where is the commitment to clean, efficient, affordable energy? Where is the commitment to wise investment in sustainable growth?




I vehemently object to the proposals filed by Duke Energy, AEP, and First Energy, seeking permission to raise consumer rates for the purpose of funding their coal power plants.



Dear Public Utilities Commission:

***I strongly oppose this proposed bailout for Duke Energy, AEP, and First Energy. Requiring consumers to buy electricity from outdated, inefficient, and dirty power plants is not in the best interest of the citizens of Ohio, whom the PUCO represents.***

In the last ten years Duke Energy (Duke) has increased rates dramatically without improving service commensurately. Consumers have repeatedly bailed out this company.

We mail our Duke Energy payments to North Carolina! The money goes into a North Carolina piggy bank, and we have only Duke's word that our payments benefit us in Ohio. Meanwhile, ***Duke has a dismal business record.***

In 2012, Duke paid \$44 million dollars to William Johnson for one day of work! In Indiana, there were charges of fraud, concealment, and gross mismanagement over Duke's handling of the Edwardsport power plant (2012). This year, "60 Minutes" did a segment on leaking coal sludge pits and the environmental damage in North Carolina.

In Ohio, Duke installed gas lines through sewer lines, and wind damaged trees in the wake of Duke's "aggressive" cutting policies. In 2010, Duke withheld \$20 million in property taxes. In February 2010, Duke "miscalculated" (generally overestimated) 100,000 bills. In 2012, Duke installed defective gas meters in Cincinnati, massive explosions rocked downtown Cincinnati, and Duke employees stole \$25 million in copper. In 2014, there was a large spill of diesel oil at Beckjord.

Last year, the PUCO approved an increase in Duke's distribution rates after *competing energy producers lowered their costs! It is time for Duke Energy to become competitive.* Please, **no more bailouts for Duke Energy.**
