**MOTION FOR EXTENSION**

Pursuant to recently effective Rule 4901:1-27-09(B) of the Ohio Administrative Code, GearyEnergy, LLC ("Geary") seeks an extension of Certificate No. 13-628E(1) which was issued in Case No. 13-40-EL-CRS. The expiration date of Certificate No. 13-628E(1) is February 3, 2015. Due to a recent change in ownership, Geary was not able to file its renewal application on time. It has now filed its renewal application on February 3, 2015 which is no later than the February 3, 2015 expiration date of its current certificate. Geary respectfully requests that Certificate No. 13-628E(1) be automatically extended from February 3, 2015 until March 5, 2015 or until the date that the new certificate is issued.

WHEREFORE, GearyEnergy, LLC respectfully requests that Certificate No. 13-628E(1) be automatically extended to March 5, 2015 or until a new certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review, so that there will be no interruption in service to customers.


**MEMORANDUM IN SUPPORT OF

Due to a recent change in ownership, Geary did not meet the January 5, 2015 filing date for its Renewal Application in Case No. 13-40-EL-CRS. Geary sincerely apologizes for the delay and assures the Commission that it will timely file renewal applications in the future. Geary emphasizes its desire to continue to serve customers in Ohio.

Recently effective Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. Geary submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 13-628E(1) issued in Case No. 13-40-EL-CRS to March 5, 2015 or until such time as a new certificate is issued so as not to interrupt service to customers.
