

MEMORANDUM IN SUPPORT

On March 3, 2013 in Case No. 13-342-EL-AGG, the Commission issued Certificate Number 13-642E, which certified Assured NL Insurance Services as a competitive retail electric service aggregator/power broker. By its terms, the certificate will expire on March 4, 2015. Assured NL Insurance Services' renewal application to extend the certification was not timely filed due to an error with the company's internal procedures.

The renewal application was required to be filed at least thirty (30) days prior to the expiration, or by February 3, 2015. However, due to a clerical error, the application was not filed until now.

Ohio Adm. Code Rule 4901:1-24-9 states:

(A) No less than thirty and no more than sixty calendar days prior to the expiration date indicated on the competitive retail electric service provider's certificate, the provider shall file an application with the commission for certification renewal on forms supplied by the commission. If the provider files such renewal application less than thirty calendar days prior to the expiration date indicated on the certificate, the provider shall file a motion to extend the expiration date on its current certificate for an additional thirty calendar days. Such motion shall be deemed automatically approved, unless otherwise ruled upon by the commission or an attorney examiner within three business days of the filing of the motion.


Assured NL Insurance Services has filed a request for a renewal application as part of this docket. Assured NL Insurance Services understands that the process for reviewing this application may take some time. Accordingly, Assured NL Insurance Services has made this request for an extension of the effective date of Certificate No. 13-642E until Assured NL Insurance Services' application can be reviewed by the Commission.

Assured NL Insurance Services requests that the Commission extend the effective date of the certificate to encompass the entirety of its review of Assured NL Insurance Services'

application, such that, if the new application is approved, there will be no break in Assured NL Insurance Services' certification.

For these reasons, Assured NL Insurance Services respectfully requests that the Commission grant its motion to extend its certification during the period in question.
