Dear Clerk of Court Staff:

The records of the Office of Attorney Services indicate that the out of state attorney named above was issued a Certificate of *pro hac vice* Registration for calendar year 2014, pursuant to Gov. Bar R. XII, "Pro Hac Vice Admission." Effective February 1, 2015, this out-of-state attorney was automatically excluded from practice in Ohio for failure to comply with the *pro hac vice* registration requirements as outlined in Gov. Bar R. XII.

You are receiving this Notice because the records of the Office of Attorney Services show that the attorney provided a "Notice of Permission to Appear *Pro Hac Vice*" indicating that he or she was granted permission to appear *pro hac vice* in the case referenced above.

If any case in which this attorney was participating on the basis of *pro hac vice* permission was pending as of January 1, 2015, the attorney was required to renew his or her *pro hac vice* registration for 2015. The records indicate this attorney has not filed an

application for *pro hac vice* registration for 2015, and is therefore automatically excluded from practice in Ohio in accordance with Gov. Bar R. XII(5).

If the case is closed, the attorney has not notified the Office of Attorney Services that this proceeding has concluded or that the attorney has withdrawn from the proceeding.

The attorney is automatically excluded from practice in Ohio until such time as the attorney petitions for reinstatement and pays the *pro hac vice* renewal registration fee with the Office of Attorney Services.

Please note that if the case has concluded, or if the attorney has been granted leave to withdraw, court staff is not required to notify our office; the *pro hac vice* attorney is required to provide such notification.
