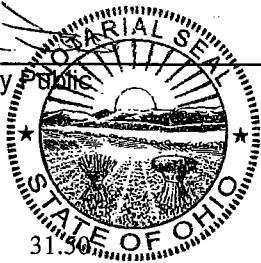

NOTICE OF AMENDMENT TO MAJOR UTILITY FACILITY

Carroll County Energy LLC has filed an application with the Ohio Power Siting Board in Case No. 14-2085-EL-BGA seeking to amend its Certificate of Environmental Compatibility and Public Need issued for a natural gas-fired combined-cycle generating facility to be located in Washington Township, Carroll County, Ohio. The purpose of the requested amendment is to add an additional construction laydown area to be located directly north of the facility site, to add the option of using an ion exchange demineralization system and to reorient the facility switchyard and make other minor internal electrical system changes.
